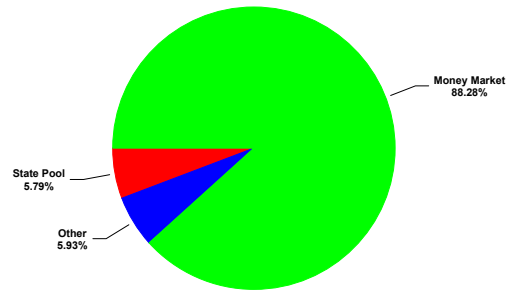

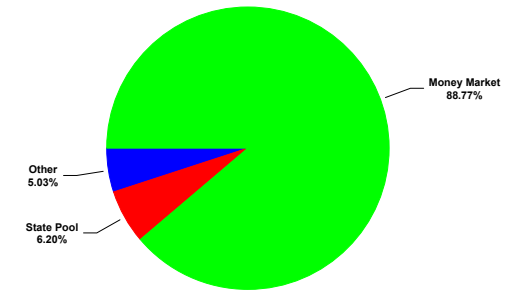

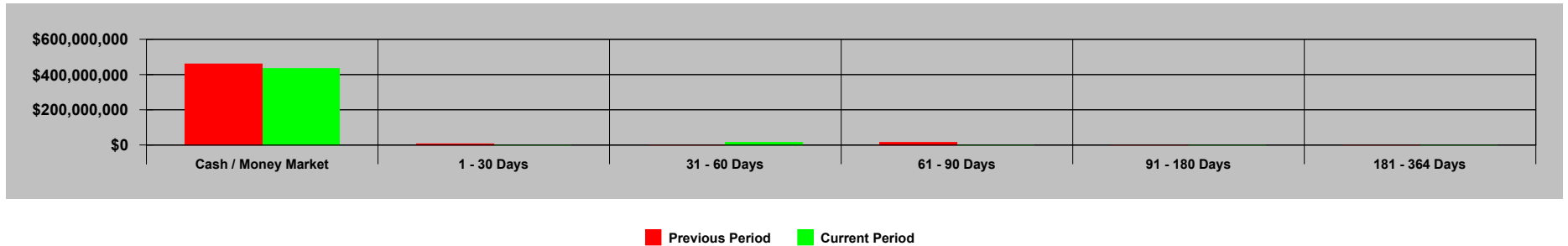
Portfolio Composition - 03/31/18



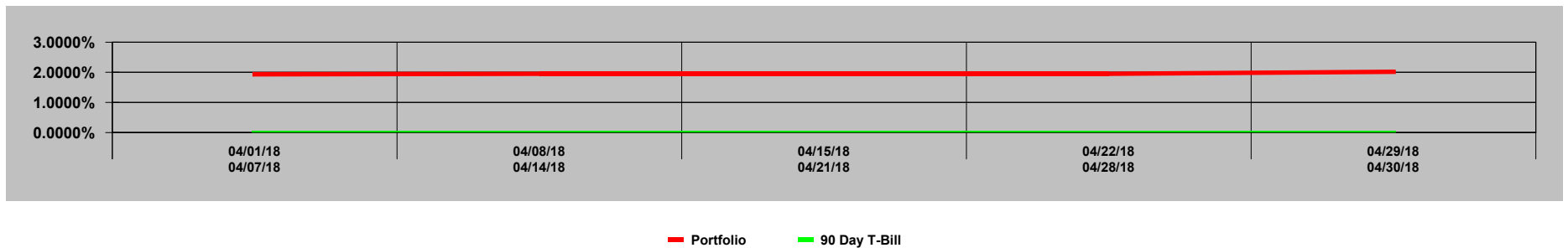
Portfolio Composition - 04/30/18

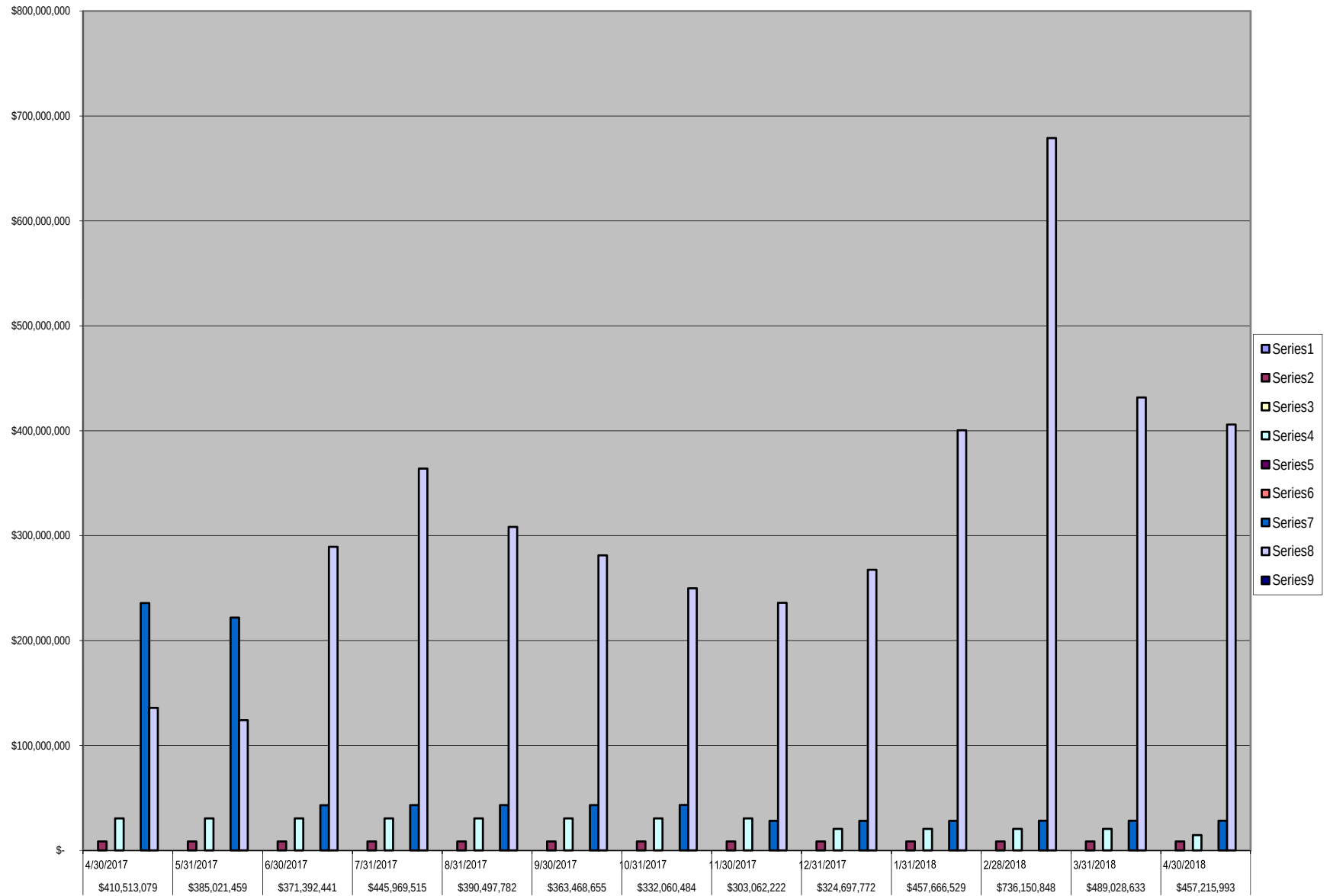

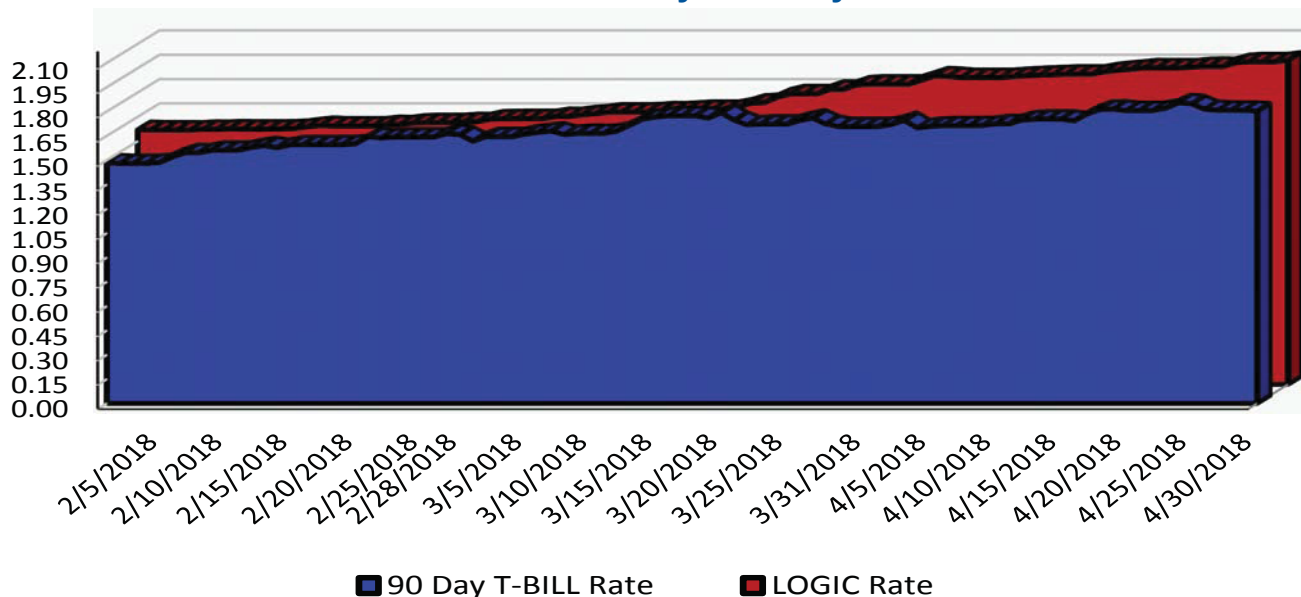
