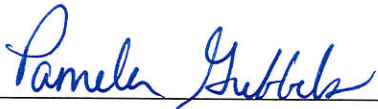

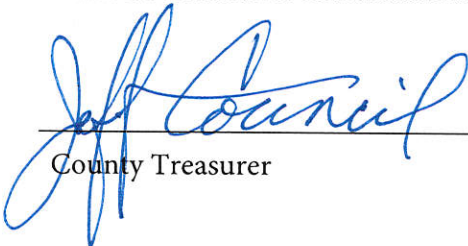

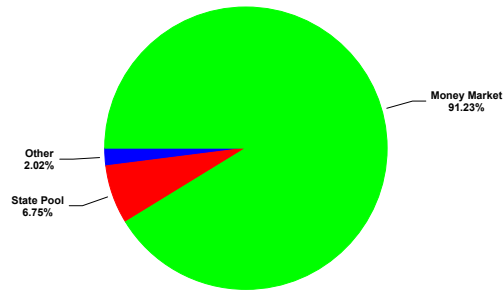

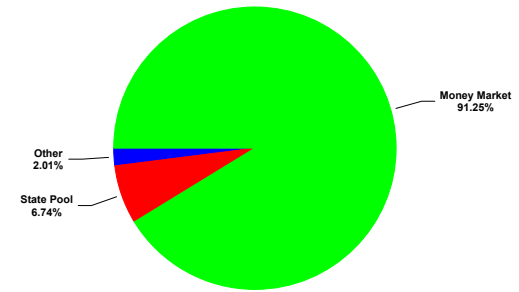

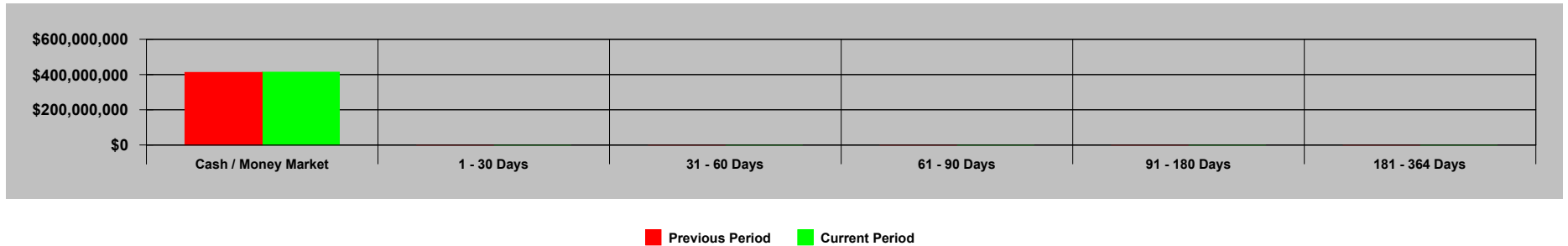
Portfolio Composition - 05/31/18



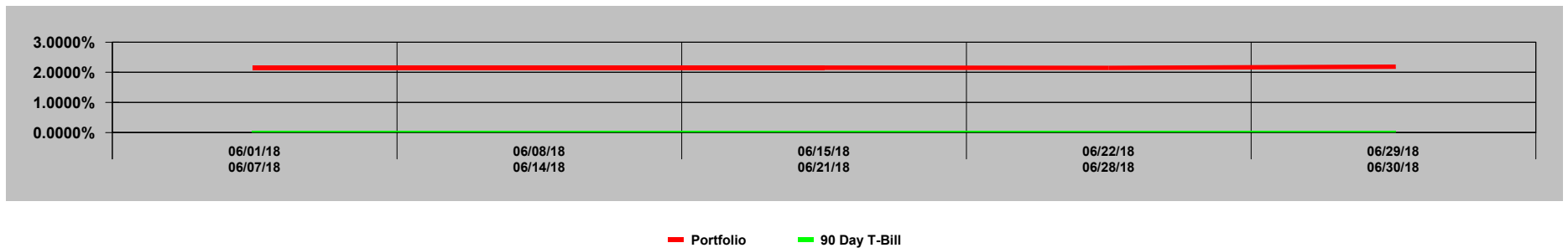
Portfolio Composition - 06/30/18

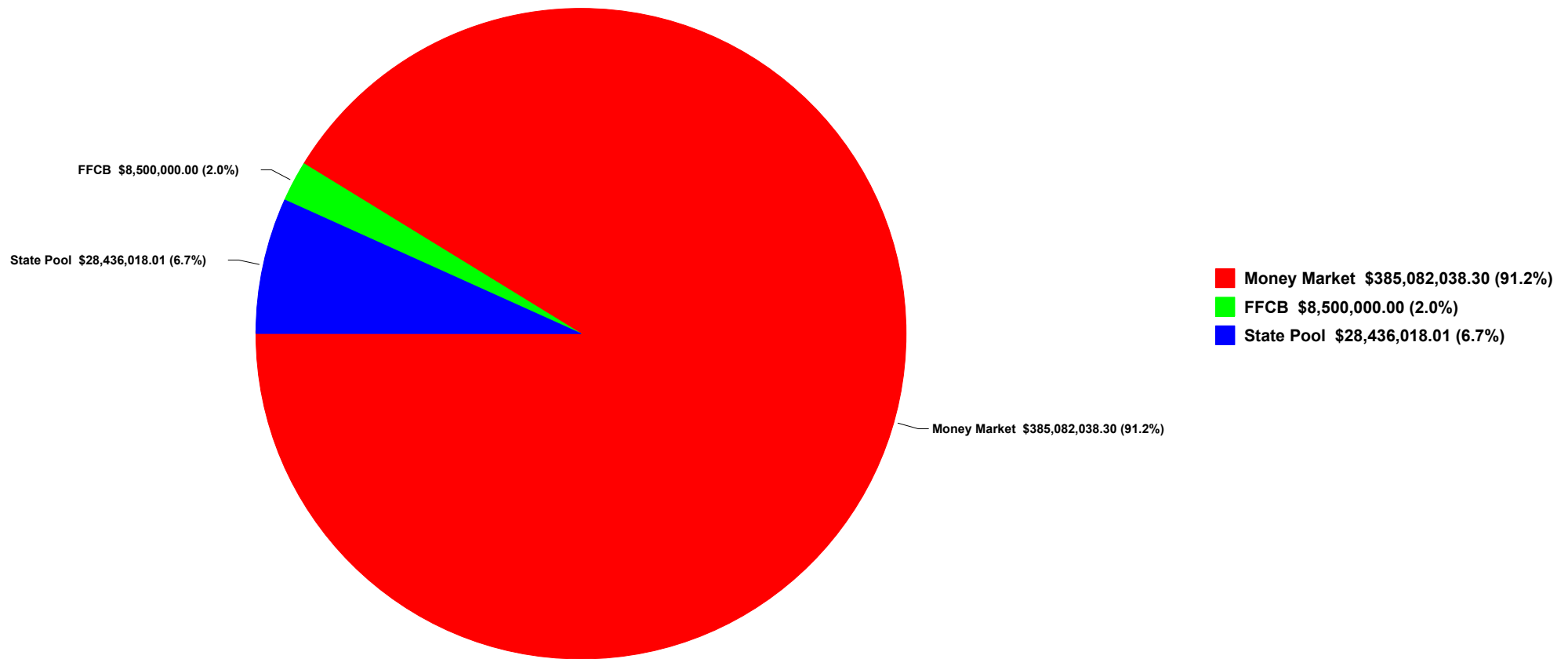

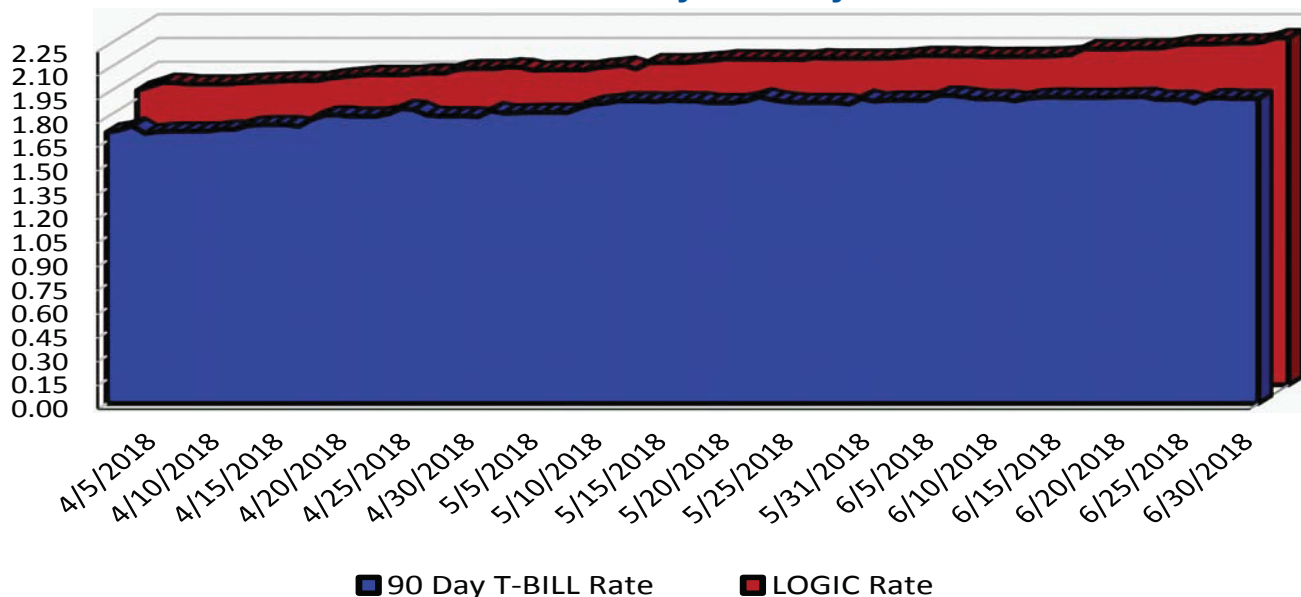
