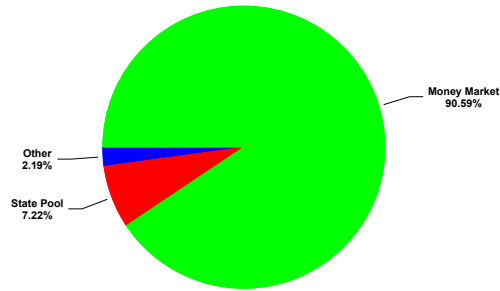

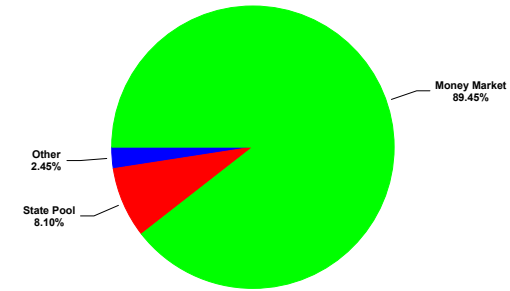

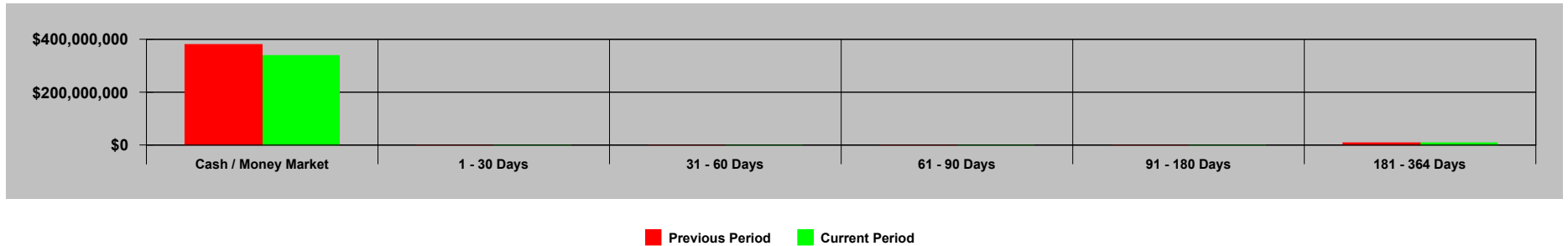
Portfolio Composition - 07/31/18



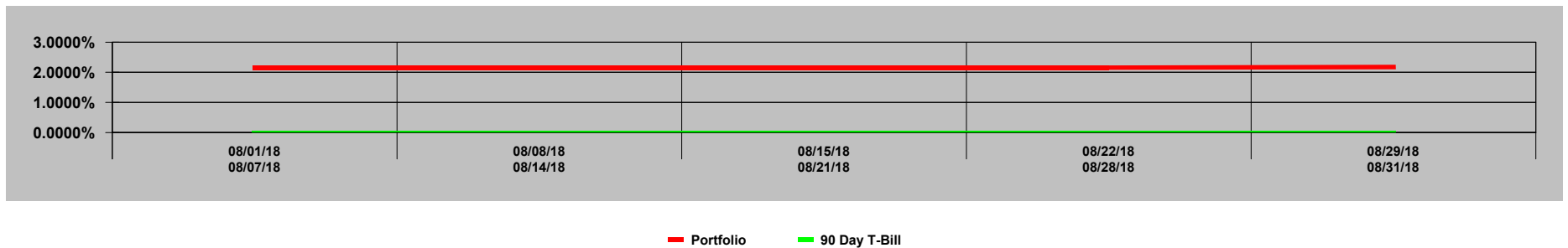
Portfolio Composition - 08/31/18

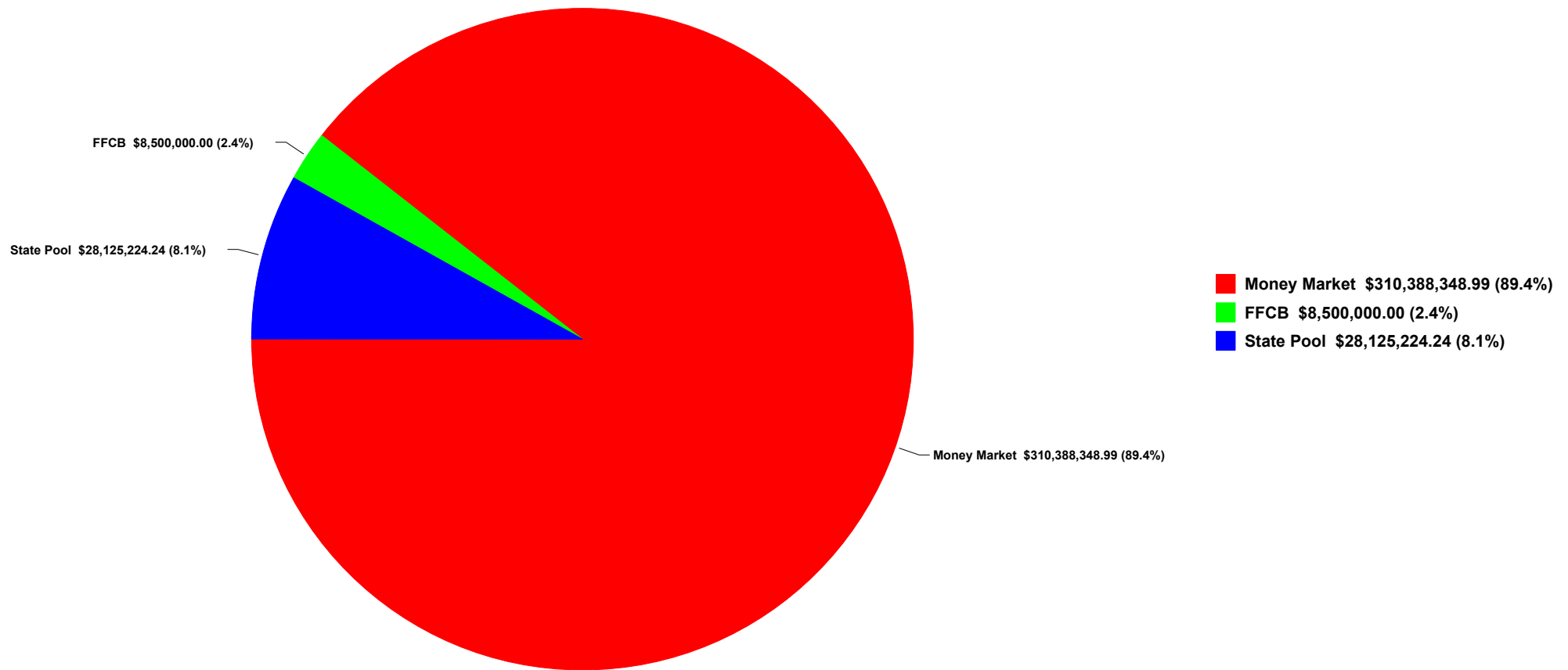

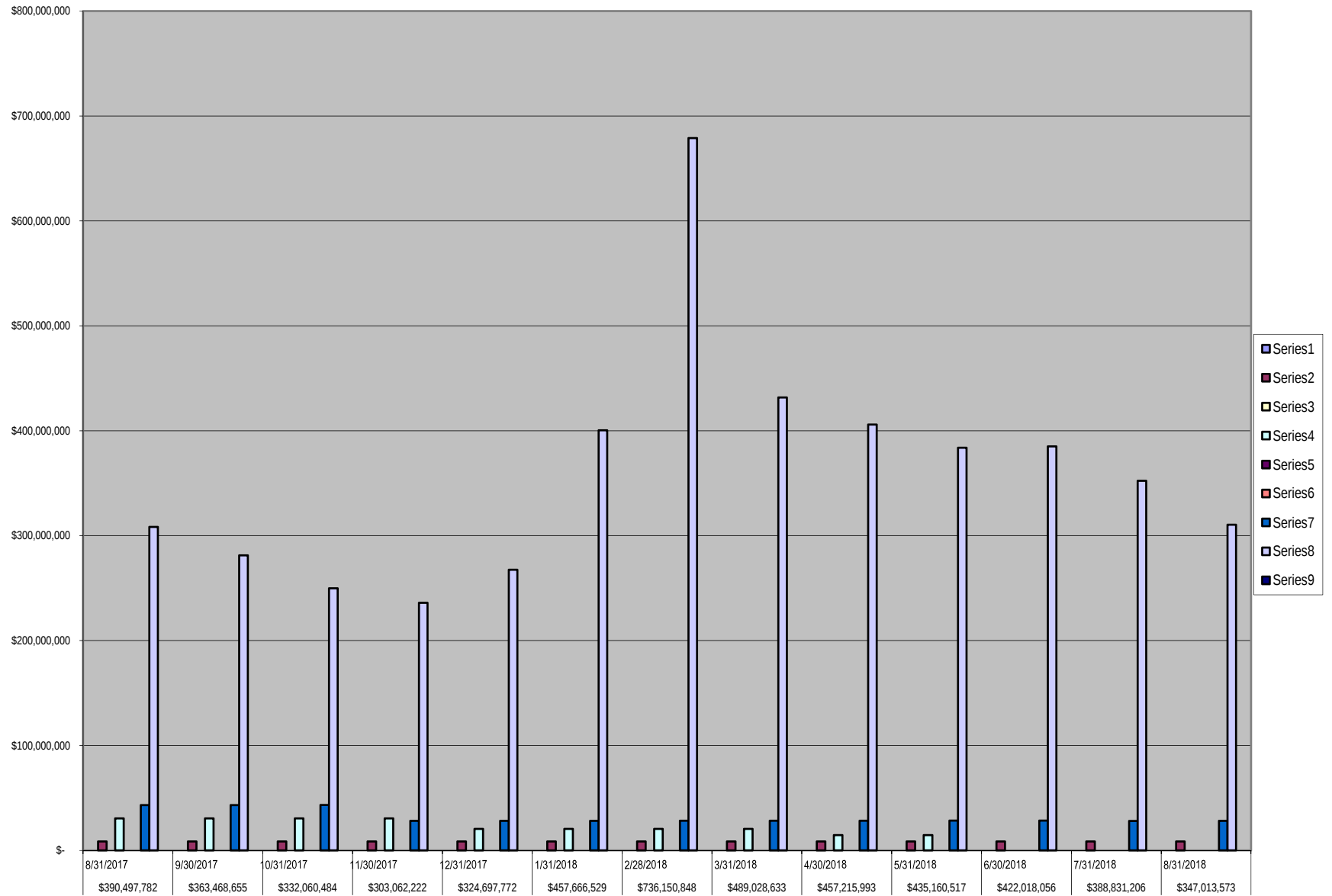

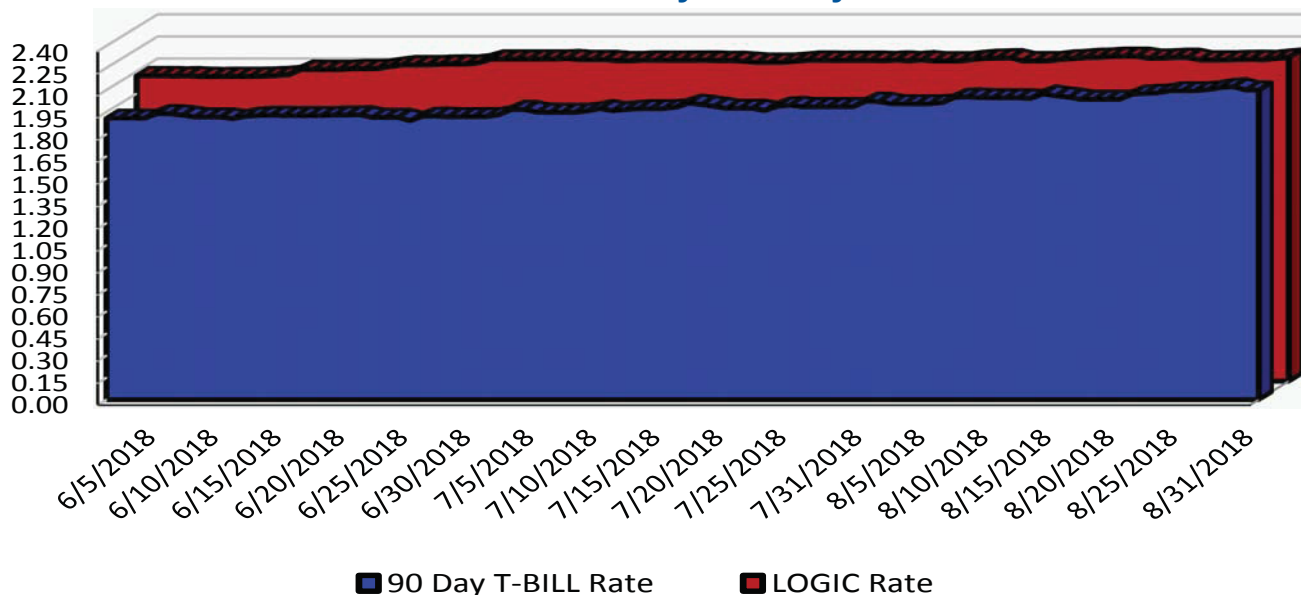
