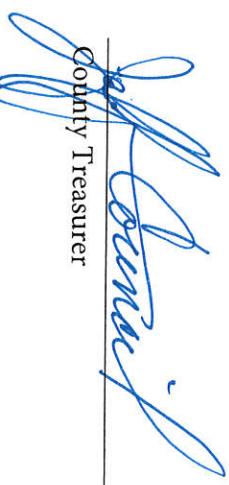

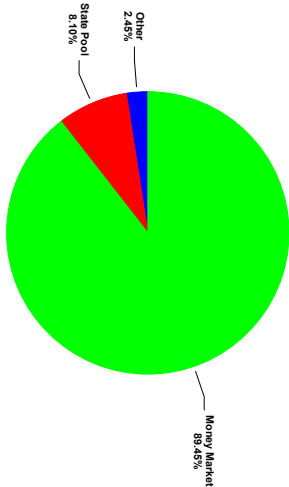

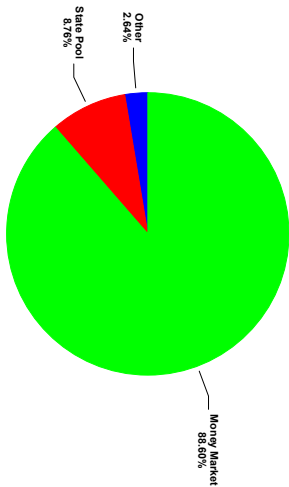

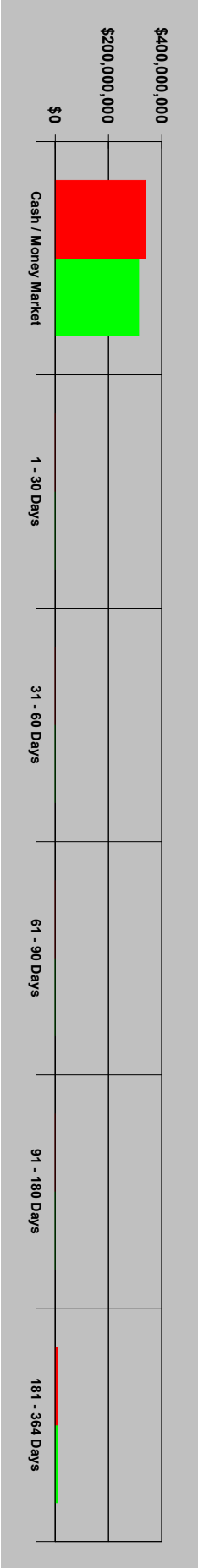
Portfolio Composition - 08/31/18



Portfolio Composition - 09/30/18

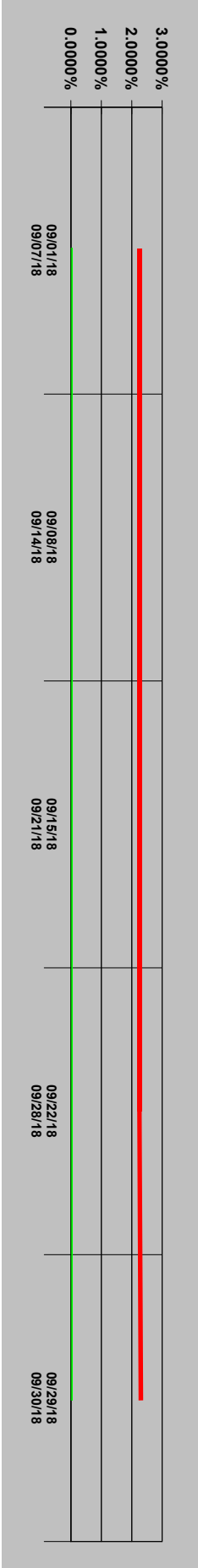


Maturity Aging - 08/31/18 vs 09/30/18

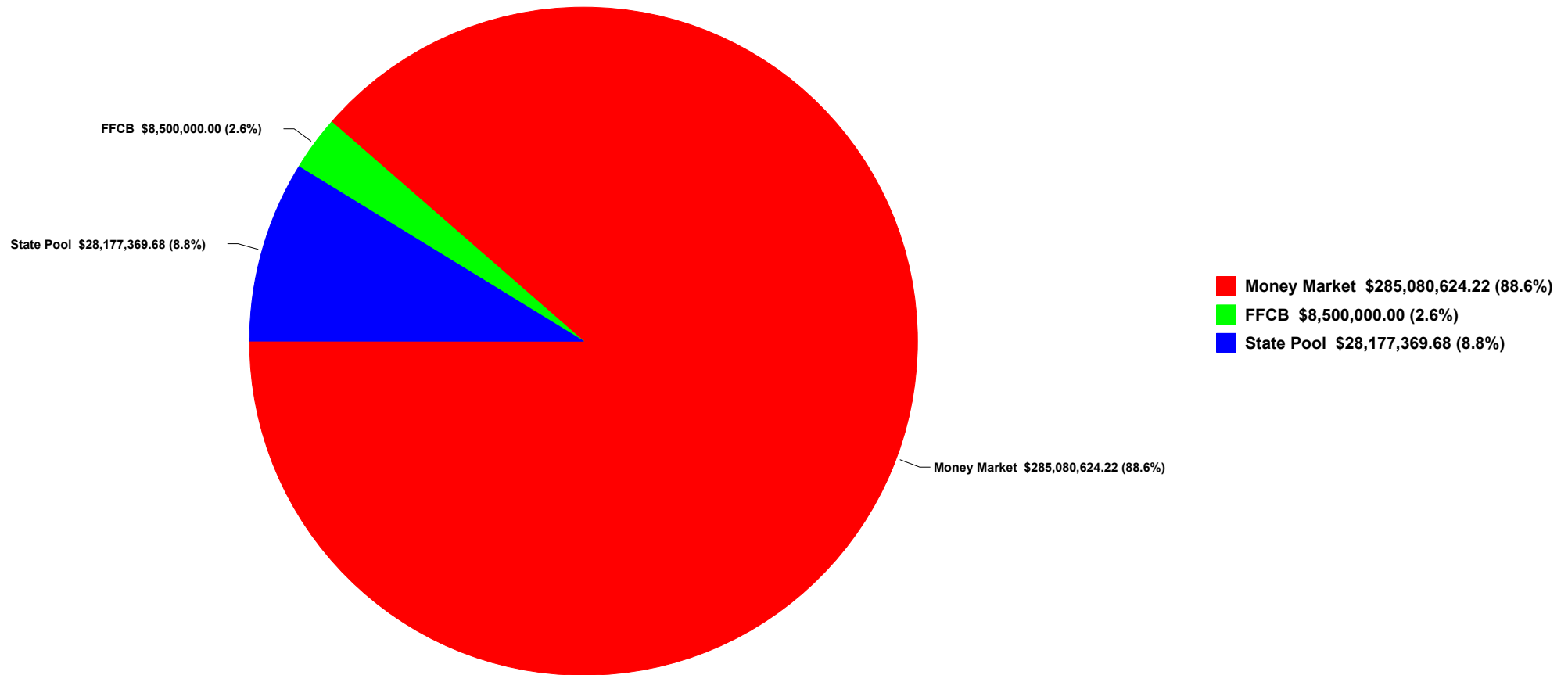

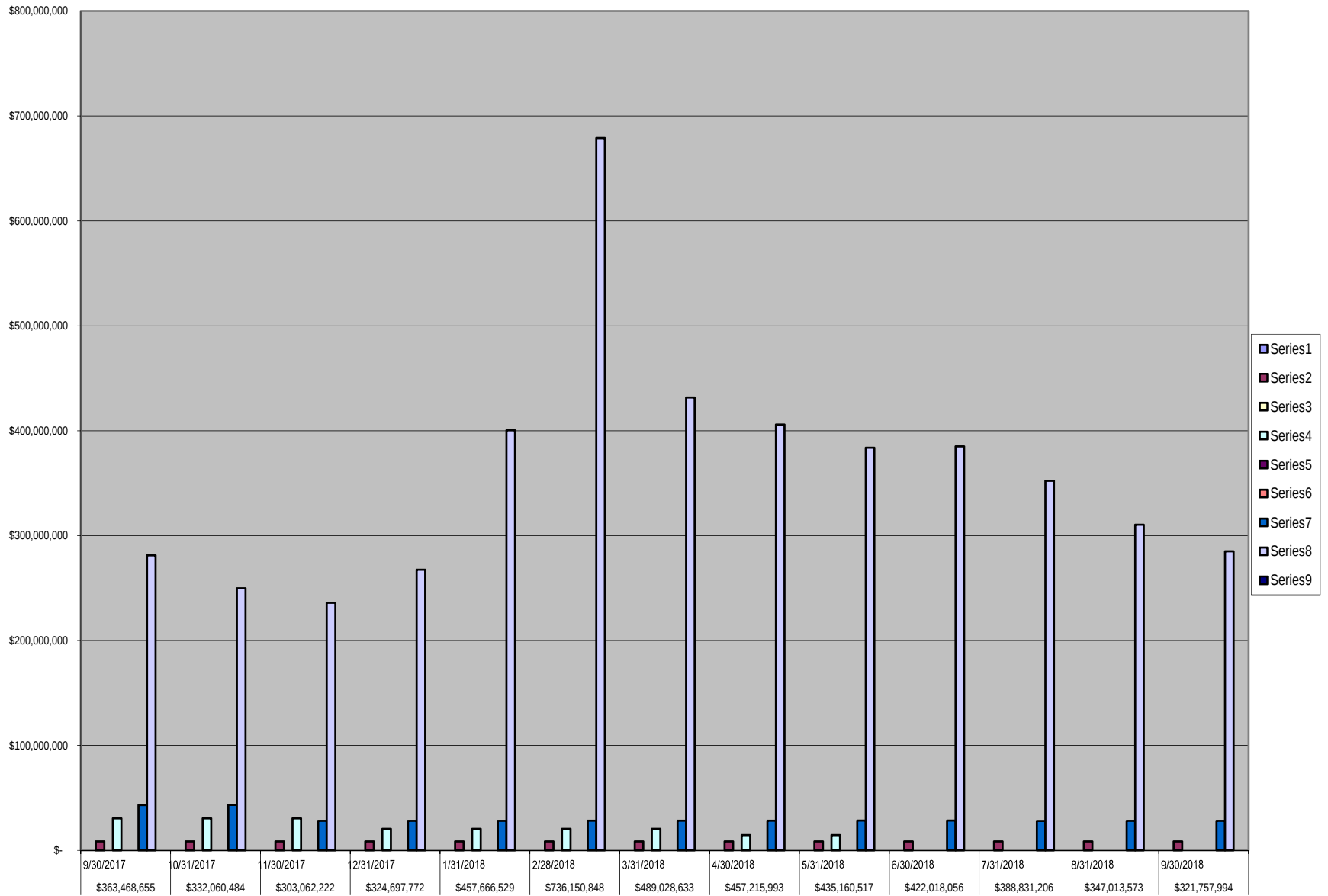

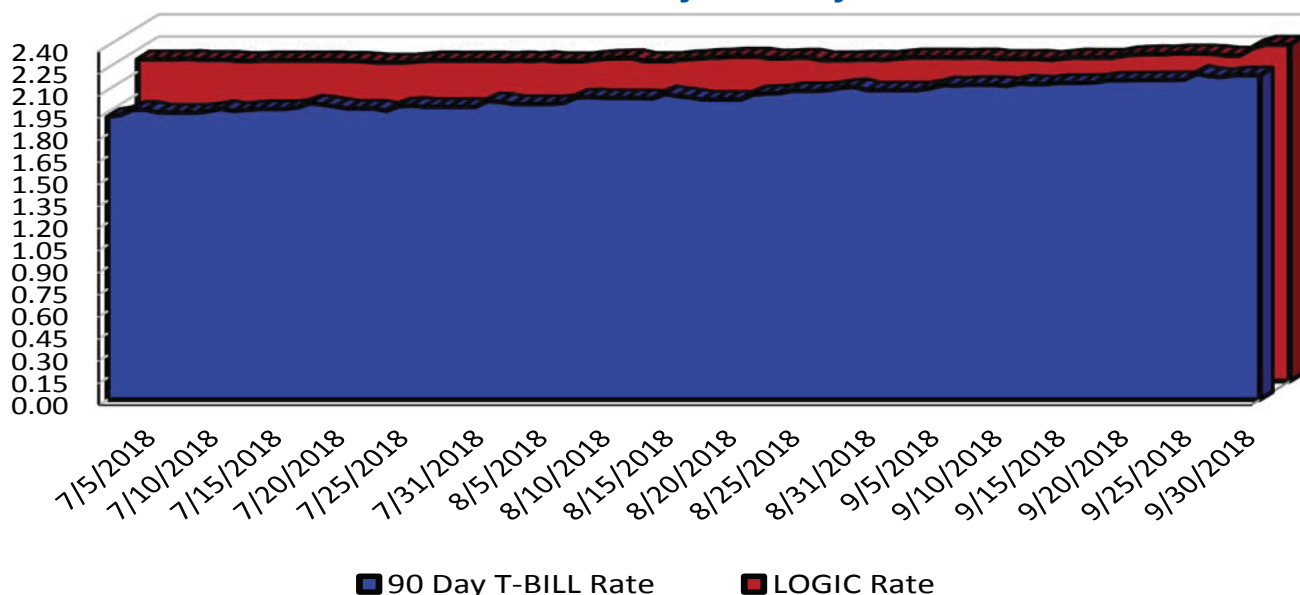
