#### Precinct 1

Michael W Elliott is requesting a waiver of penalty and interest for the 2006-2017 tax years, stating that the above improvement only account was added to the appraisal under an erroneous owner name and tax statements since 1982 were mailed to an erroneous address.

Tax Office records and research indicate:

- 1982 Fort Bend County tax office received tax records from the Fort Bend Central Appraisal District for account number 7395-00-119-0134-901 legal description Richmond, Block 119, Lot 13 & (N 30') Lot 14, Imps only A/J on account -119-0132, naming the owner A W Winfrey with the mailing address 402 Austin St, Richmond, TX 77469-4406.
- 2. 2002 through 2017– per notes on the account statements and notices mailed to: 402 Austin St. Richmond, TX 77469-4406 were returned due to various reasons including no such number.

- 3. 1982 through 2005 taxes were written off during 10/20 Year Write Off per Texas Property Tax Code Section 33.05 "Limitation on Collection of Taxes".
- 4. The tax office researched the property history and no deed could be found in Fort Bend County records naming A W Winfrey as the owner of the improvement only account.
- 5. July 17, 2018 A deed was filed at the Fort Bend County Clerk's Office. Per deed filed on this date, it recorded the owner as Lone Star Trial LLC; 310 Morton St. 99, Richmond, TX 77469-3119.
- 6. October 22, 2018 Tax Office received 2018 Supplement 2 from the Fort Bend Central Appraisal District deleting the improvement only account for 2018 and combining it with 7395-00-119-0132-901 "land account" and changing the ownership to Lone Star Trial LLC.
- 7. September 10, 2018 Tax Office received payment for 2006 2017 taxes in the amount of \$8,865.56 including September penalty, interest and collection fees.
- 8. There is evidence of an error by the Fort Bend Central Appraisal District.
- 9. Lamar CISD and City Of Richmond have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on Section 33,011 of the State Property Tax Code.

# REQUEST FOR WAIVER OF PENALTY, INTEREST & FEES PURSUANT TO TEXAS PROPERTY TAX CODE SECTION 33.011

Dear Judge and Commissioner:

In mid-July of 2018, I, under the name of Fort Bend Trial PLLC, purchased the North 30' of Lots 13 & 14 in Block 119 of the City of Richmond, and being more commonly known as 101 S. 3rd Street, Richmond, Texas 77469. [For reference point this is the property located directly across the street from the Lone Star Saloon in downtown Richmond]. The land was carried under 7395-00-119-0132-901 tax account (R112696) and I knew at the time of the purchase that the land had some arrears on the taxes on behalf of the previous owner Jovita Thorn.

However, for still unknown reasons, additional property had been added to the appraisal roll under a different account number or parcel 7395-00-119-0134-901 (R112698) under the stated owner name of A.W. Winfrey and which was listed as an "improvement only". As it turns out, that property had a substantial amount of Tax arrearage, penalties, interest and fees associated with it and is the basis of the request for refund made herein.

Upon discovering the apparent problem and associated tax delinquency on the stray added account, I went to the appraisal district office and enlisted their assistance to attempt to try and find out why a separate tax account had been added in the A.W. Winfrey name for improvements only. On September 10, 2018, after the conclusion of their research at the appraisal district, I met with Glen Whitehead and others in his office to discuss their findings. The research had determined that the tax, penalties, interest and fees had been assessed against the property for the added "improvement only" account since at least 2006 and that taxes, penalties, interest and fees were in fact due and owing on the account and were in fact attached to this property. However, no justification could be found in their records as to why the account was created. A.W. Winfrey never owned the property, nor was the address his bill was sent to even a valid address for any of the actual previous owners. Therefore, due to an error of the appraisal district back before the Glen Whitehead administration which was not caught until I purchased the property, the tax statements and bill has been sent to an erroneous owner and erroneous address since at least 2006 which has no legal connection to the property.

Despite the discovered appraisal district error, I, as required by law, paid the entirety of the Taxes, Penalties, Interest and Fees owed against the property for Tax Accounts R112696 & R112698 on the same day as the Appraisal District notified me of their findings on September 10, 2018 in the total amount of \$11,458.76.

Therefore, pursuant to Texas Property Tax Code Section 33.01(i), I am hereby timely as required by law, formerly in writing requesting a refund of the Taxes, Penalties, Interest and Cost as associated with the erroneously added improvement account (R112698 A.W. Winfrey) in the amount of [\$4,756.35 (\$3,278.77 P&I + \$1,477.58 Coll Fee)]. (Tax receipt Statement incorporated and attached hereto as "Exhibit A")

Please place this matter on the commissioner's court agenda at your earliest convenience for the requested approval of this refund as allowed by law. In my dealings with the appraisal district, this matter has now been cleared up and consolidated into one account so that this issue will not re-occur again in the future.
