**WHEREAS**, the County Court of Commissioners finds it in the best interest of the citizens of Fort Bend County, that the Felony Drug Court (CARD), Misdemeanor Drug Court and Misdemeanor DWI Court programs be operated for the fiscal year 2019; and

**WHEREAS**, the County Court of Commissioners agrees that in the event of loss or misuse of the Office of the Governor Criminal Justice Division program funds, the County Court of Commissioners assures that the funds will be returned to the State grant administrator, the Office of the Governor, in full; and

**WHEREAS**, the County Court of Commissioners previously designated Robert E. Hebert, Fort Bend County Judge as the grantee's authorized official on February 13, 2018.

**WHEREAS**, the County Court of Commissioners now designates KP George, Fort Bend County Judge as the grantee's authorized official, to reflect the new holder of the office of County Judge. The authorized official is given the power to apply, reject, alter or terminate the grant on behalf of the applicant agency.

**NOW THEREFORE, BE IT RESOLVED** that the County Court of Commissioners approves submission of the grant application listed above to the Office of the Governor.
