Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011\*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. Jesus & Nivea Rodriguez are requesting a waiver of penalty, interest and collection fees for the 2017 tax year, stating that 2017 statement was never received because the property is a lot. Taxpayer also stated that he believed taxes were included in his payments to the bank until the bank informed him that he was responsible for taxes.

- February 20, 2018 2017 Reminder Notice mailed to Rodriguez Jesus & Nivea M, 32118 Rolling Woods Trl, Fulshear TX 77441. This statement was returned by the post office on 02/28/2018 No Mail Receptacle.

- May 23, 2018 2017 33.07 Notice mailed to Rodriguez Jesus & Nivea M, 32118 Rolling Woods
  Trl, Fulshear TX 77441. This statement was returned by the post office on 06/01/2018 No
  Mail Receptacle.
- November 9, 2018 Received payment from Jesus & Nivea Rodriguez for 2017 taxes, including penalty, interests and collection fees.
- November 9, 2018 Received change of address request from Jesus Rodriguez to change mailing address to 26715 Rimcrest Ct, Katy TX 77494; Request forwarded to Ft Bend Central Appraisal District.
- There is no evidence that an error was made by the Fort Bend County Tax Office or the Fort Bend Central Appraisal District.
- Lamar CISD and Fort Bend ESD #4 have authorized Fort Bend County Tax Office to handle the
  processing of the waiver of penalty, interest and collection fees and allow the Fort Bend County
  Commissioners Court to make the determination based on Section 33.011 of the State Property
  Tax Code.
