- March 18, 2019 The Fort Bend County Tax Office received a payment of \$13,187.87 (including March penalty and interest)

- There is no evidence of an error by the Fort Bend Central Appraisal District or the Fort Bend County Tax Office.
- Lamar CISD, Fort Bend ESD#4 and City of Fulshear has authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on Section 33.011 of the State Property Tax Code.
