### Extended Budget Description

The County currently contracts with First Transit to provide turn-key bus service. We follow 9030.1E at 40% Capital because we are providing our own vehicles. Funds are currently being expended under Pre-Award Authority. The remainder of the turn-key bus services will be funded at 60% operating for a 50/50 split. Total contract award through 09-30-2023 is estimated at \$31,024,370.

Total Federal is \$26,497 with local match in the amount of \$6,625 (20%) to be provided by the County from the FY2019 General Revenues.
