Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011\*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. Tax Office records and research indicate:

- November 2, 2018 2018 Certified Tax Statement for account # 7600-06-001-0010-907 was mailed to: Michael A Rea & Dawn F Lin, 13935 Hidden Lake Ln, Sugar Land, TX 77498-2664. This statement not was returned by the Post Office.
- February 13, 2019 2018 Reminder Notice was mailed to: Michael A Rea & Dawn F Lin, 13935 Hidden Lake Ln, Sugar Land, TX 77498-2664. This statement was not returned by the Post Office.
- February 18, 2019 Tax office received a call from the tax payer for waiver instructions of penalty and interest.
- February 26, 2019 Received payment from Michael A Rea in the amount of \$7,818.03, including February 2018 penalty and interest.

- There is no evidence of an error by the Fort Bend County Tax Office or the Fort Bend Central Appraisal District.
- Fort Bend ISD and City of Sugar Land have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioner's Court to make the determination based on 33.011 of the State Property Tax Code.

## Dear Judge George

I am writing to request consideration for a waiver of penalty and/or interest due to late payment of our 2018 property tax. The reason for the late payment is that the incorrect address was used to mail the check to the Fort Bend County Tax Assessor/Collector. I have enclosed the photocopy of the returned envelope containing the check for our homestead property described below. You will note that (1) the envelope was mailed before the deadline, (2) the envelope was returned as undeliverable, and (3) the envelope has not been opened.

As per the "Instructions for waiver of penalty and interest per section 33.011 of the Texas Property Code", I paid the outstanding tax plus penalty and/or interest within the 21 day window using the online, automated system. This is the first time in 20 years that I/we have failed to pay our property tax in a timely manner. I accept full responsibility for the error, and appeal to the Court to grant this waiver as per 33.001.
