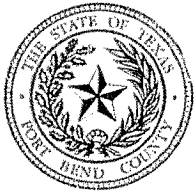

### Precinct 4

Joseph and Laurie Wallace, are requesting waiver of penalty and interest for the 2018 tax year stating the Fort Bend Tax Assessor's office claimed he was responsible when a payment of dispute was not communicated properly to him on the late fee. He also stated that he was given verbal assurance over the phone with a Tax Assessor Collection representative who provided incorrect guidelines on the matter.

Tax Office records and research indicate:

- November 2, 2018 – 2018 Certified Statement for account # 3104-03-001-0320-907 was mailed to: Joseph and Laurie A Wallace, 20215 Pebble Holw, Richmond, TX, 77407-4181. **This statement was not returned by the Post Office.**

- January 25, 2019 – Received payment for 2018 taxes from Joseph and Laurie A Wallace in the amount of \$4,792.56.
- February 8, 2019 – Received notification from Prosperity Bank that the payment made on January 25, 2019 in the amount of \$4,792.56 was returned for insufficient funds.
- February 8, 2019 – A Letter and 2018 Delinquent Statement was sent to Laurie A Wallace, 20215 Pebble Holw, Richmond, TX, 77407-4181 notifying tax payer their check was returned for insufficient funds. The letter states their payment was removed from the system and taxes are now due in the amount of \$5,158.04 including the \$30.00 return check fee if paid by February 28, 2019. -- **This letter and statement was not returned by the Post Office.**
- February 12, 2019 – Tax payer called to verify the amount due and stated they would be going into the Katy annex to pay.
- February 13, 2019 – Joseph Wallace came into the Katy annex upset that he had not yet received a letter informing him of the amount due with penalty & interest. He stated he called the office on 01/25/2019 and spoke with Rosio informing us of the return for not having a name on the check. He also stated he was informed at that time he had 21 days to pay without penalty and interest. The clerk informed him that there is no one by the name Rosio that works for the tax office and advised him to file a waiver for the penalty and interest.
- February 13, 2019 – Received partial payment from Joseph Wallace in the amount of \$4,822.56 attempting to pay base levy only and return check fee.
- February 14, 2019 – Joseph Wallace paid the remaining amount due of \$335.48 including February 2018 penalty and interest
- There is no evidence of an error by the Fort Bend County Tax Office or the Fort Bend Central Appraisal District.
- Fort Bend Independent School District and Fort Bend LID #12 have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty, interest, and collection fees and allow the Fort Bend County Commissioner's Court to make the determination based on 33.011 of the State Property Tax Code.

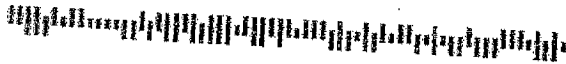

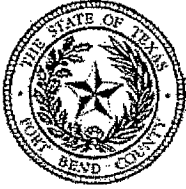
