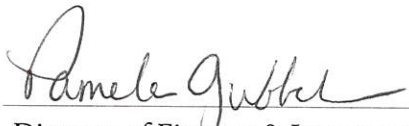

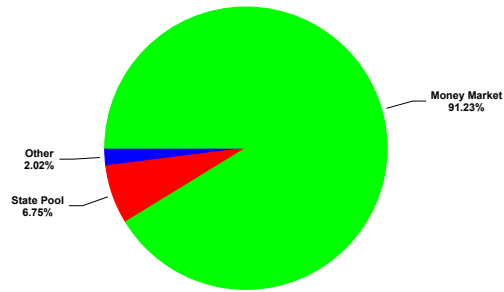

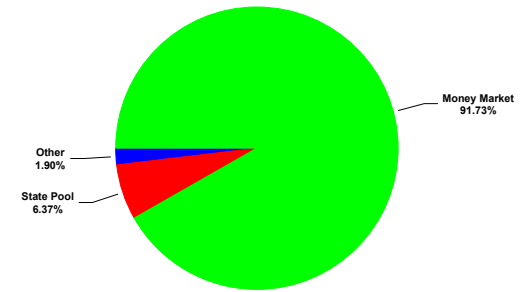

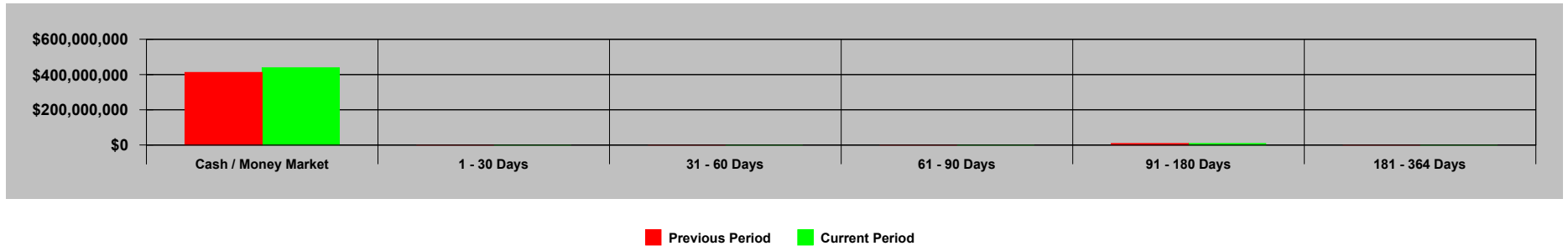
Portfolio Composition - 01/31/19



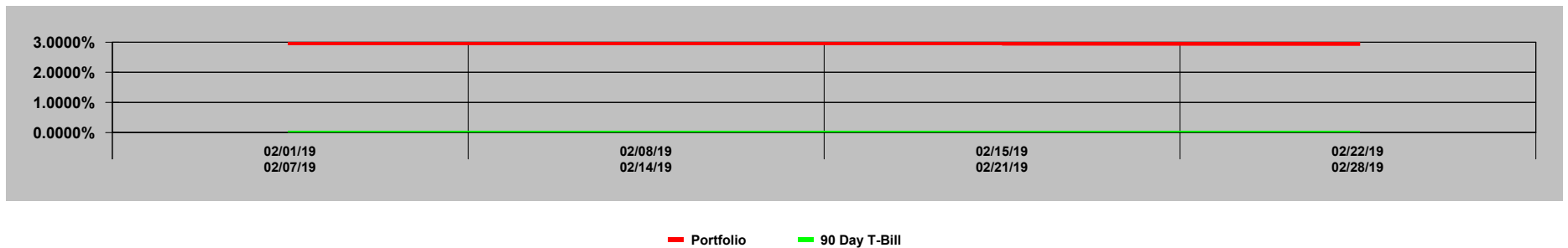
Portfolio Composition - 02/28/19

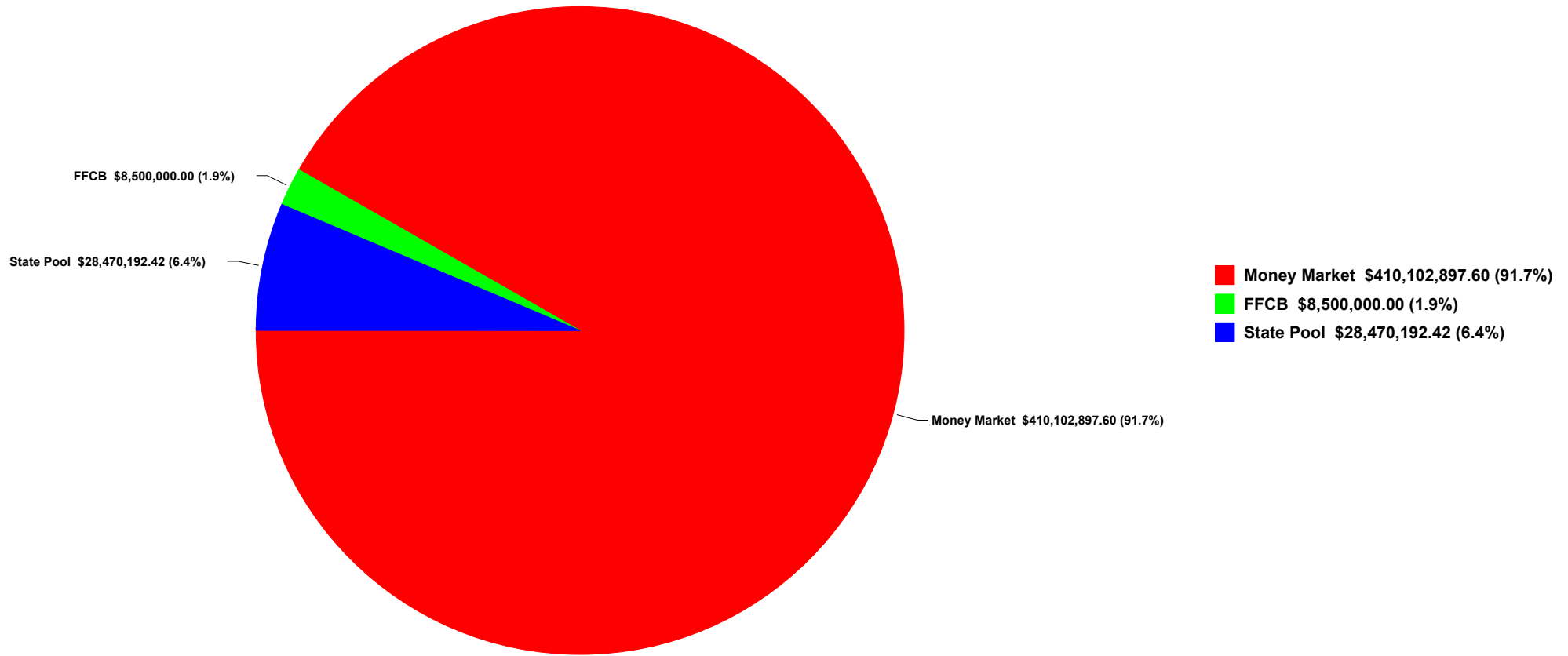

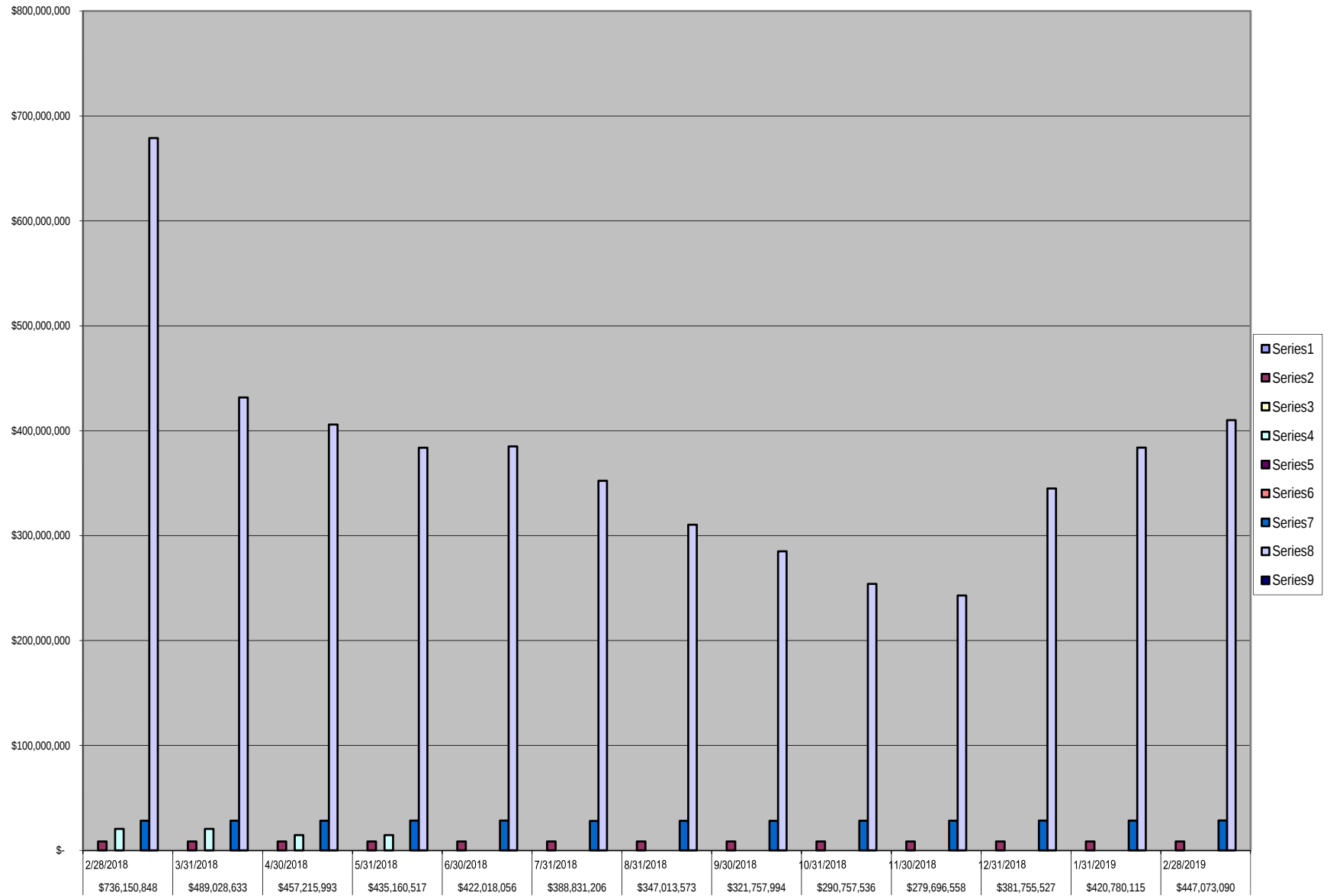

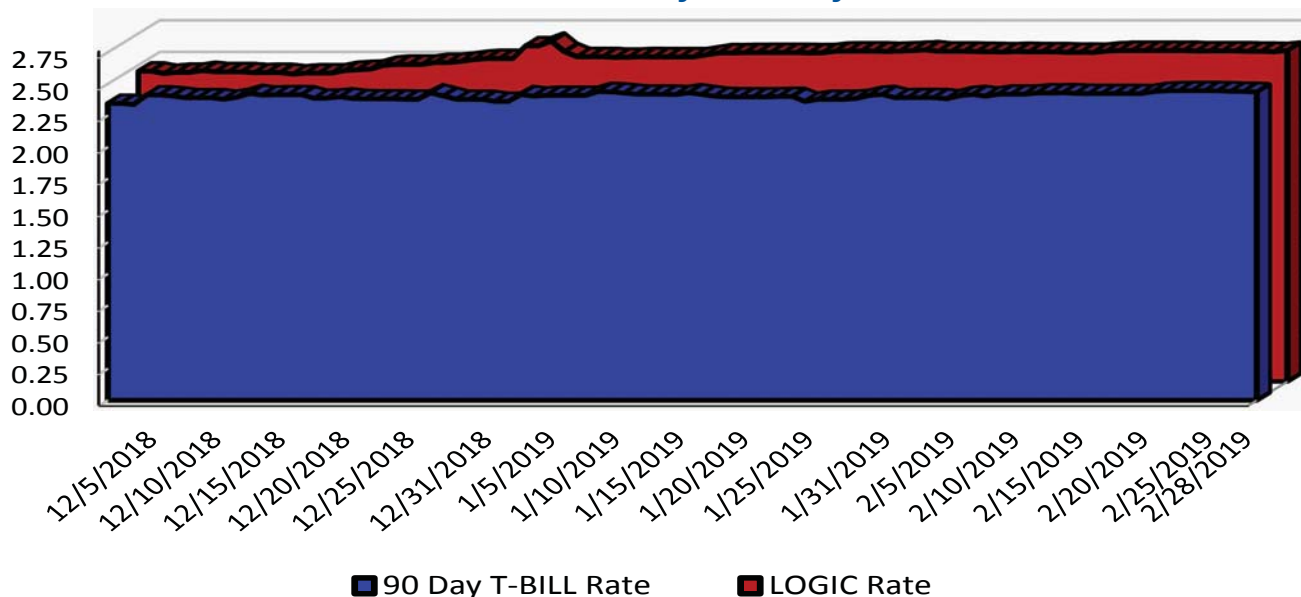
