

INFORMATION REQUIRED PER TEXAS TAX CODE SECTION 312.207 (C) (1): FOR THE TAX ABATEMENT AGREEMENT TO BE PRESENTED APPEARS BELOW:

- (1) The name of the property owner and applicant for the tax abatement agreement is: Braes Bayou Generating, LLC, a project of ProEnergy LLC.
- (2) The Property is located in Fort Bend County Reinvestment Zone 27; more specifically described as approximately 20.104 acres, located just north of the northeast corner of Lockwood Road and Lockwood Bypass Road in unincorporated Fort Bend County, Precinct 1.
- (3) The improvements for the property are a control room building with equipment and machinery on a 400,000 square feet plant site.
- (4) The estimated cost of improvements are approximately \$1.1 million dollars.


This public notice is being posted at least 30 days before the scheduled time of the meeting. The Abatement Agreement will appear on the Notice of Meeting that will be issued for the actual scheduled meeting and will be given in accordance in the manner required by Chapter 551, Government Code.
