

**INFORMATION REQUIRED PER TEXAS TAX CODE SECTION 312.207 (C) (1):  
FOR THE TAX ABATEMENT AGREEMENT TO BE PRESENTED APPEARS BELOW:**

- (1) The name of the property owners and the names of the applicant for the tax abatement agreement: SIE Real Estate Services, LLC and Si Environmental LLC.
- (2) The name and location of the reinvestment zone in which the property subject to the agreement is located: Rosenberg Reinvestment Zone 23 is located in Precinct 1 in the Rosenberg Business Park.
- (3) A general description of the nature of the improvements or repairs included in the agreement: Projected improvements: a total of two buildings consisting of offices and operations totaling 62,000 square feet.
- (4) The estimated cost of the improvements or repairs: Initial capital investment for the project is \$8.1 Million.

This public notice is being posted at least 30 days before the scheduled time of the meeting. The Abatement Agreement will appear on Notice of Meeting that will be issued for the actual scheduled meeting and will be given in accordance in the manner required by Chapter 551, Government Code.
