conduit and/or pole line activity, commercial driveway and median openings or modifications;


NOW, THEREFORE, if the above bounden principal shall faithfully perform all its cable, conduit and/or pole line

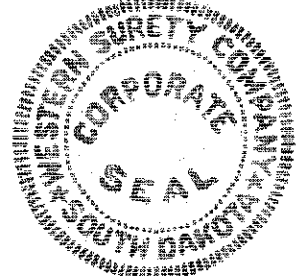

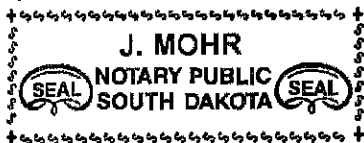
