**SECOND AMENDMENT TO AGREEMENT FOR  
ARCHITECTURAL ADMINISTRATION SERVICES  
SOQ 16-045**

**THIS SECOND AMENDMENT**, is made and entered into by and between Fort Bend County, (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and STOA Architects (hereinafter “Consultant”), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Architectural Construction Administration Services on or about December 18, 2018, (hereinafter “Agreement”), as amended by document executed on February 4, 2020, (hereinafter “Amendment”); and

WHEREAS, the parties desire to further amend the Agreement to increase the Maximum Compensation payable to the Contractor under the Agreement.

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. County shall pay Contractor an additional amount not to exceed two thousand two hundred dollars and no/100 (\$2,200.00) for additional fees as reflected in Exhibit A, attached hereto and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed thirty-four thousand nine hundred dollars and 00/100 (\$34,900.00), authorized as follows:
  - \$22,800.00 under the Agreement;
  - \$9,900.00 under this Amendment; and
  - \$2,200.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and any amendment thereof exceed the Maximum Compensation without an agreement executed by the parties.
4. The parties hereby agree the terms and conditions of the Agreement have remained in effect to date and the Time of Performance shall be extended to end no later than six (6) months hereafter.

5. BY ACCEPTANCE OF AGREEMENT, CONSULTANT ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement and any subsequently executed amendment shall remain unchanged.

IN WITNESS WHEREOF, the parties hereto have signed or have caused their respective names to be signed to multiple counterparts to be effective on the date signed by the final party.
