- (1) Cutlass Solar, LLC is the property owner and applicant for the amended tax abatement agreement;
- (2) The Property is located in Reinvestment Zone 23 in Fort Bend County, Pct. 1, Texas. More specifically described as: off the southeast corner of the intersection of State Highway 36 and FM 1995.
- (3) The improvements or repairs for the property are a Solar Energy generation facility located on approximately 700 acres.
- (4) The estimated cost of the improvements or repairs are **\$70,000,000**
(a reduction from original abatement agreement for \$210,000,000)

The Amended Abatement Agreement will appear on the Notice of Meeting that will be issued for the actual scheduled meeting and will be given in accordance in the manner required by Chapter 551, Government Code.
