**AMENDMENT NO. 2 TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES FOR
EMERGENCY WATERSHED PROTECTION PROGRAM FOR OYSTER CREEK (PHASE II)

THIS AMENDMENT, is made and entered into by and between Fort Bend County Drainage District (hereinafter "DISTRICT"), a body corporate and politic under the laws of the State of Texas, and M&E Consultants, LLC, (hereinafter "Consultant"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services related to Project Number 2017 48157 FBDD-005 on September 24, 2019 pursuant to RFQ 19-077, and amended on August 25, 2020, (hereinafter "Agreement") which is incorporated by reference as if set forth herein verbatim; and

WHEREAS, the parties desire to amend the Agreement to extend the Time of Performance under the Agreement and to modify the list of federal requirements;

NOW, THEREFORE, the parties do mutually agree as follows:

1. The time for performance of the Services shall be extended ending on February 7, 2022.
2. Contractor understands and acknowledges that this Agreement may be totally or partially funded with federal and or state funds from the National Resource Conservation Service (NRCS) and the United States Department of Agriculture (USDA). As a condition of receiving these funds, Contractor represents that it is and will remain in compliance with all federal and or state terms as listed on Exhibit A, Federal Clause Requirements.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
