DESCRIPTION OF MODIFICATION/CHANGE ORDER

Pursuant to General Condition, Article 14.4, the contract shall be modified as following.

The Contractor shall furnish all material, equipment, and labor to install Steel Pipe Piles as shown on contract Drawing 5(as modified in Change Order 3), installation of the steel Pipe piles shall be accomplished on Sites 415, 417, 416 and 413 (revised location). Sites 146 and 417 were included in Mod 4 however the pipe piles were not included in the quantity.

Compensation shall be in accordance with the applicable added items below. Contractor Quality Control shall be accomplished in accordance with Construction Specification 94 for the added work.

Location of Site 416 shall be relocated downstream of its current location as shown on the attached drawing. The alignment of the steel sheet pile wall shall be changed as shown on the attached drawing. No change in contract price.

On Site 436, the contractor shall furnish off site material for earthfill of the fill required to complete the slope as specified on the plans. Compensation shall be accomplished as a lump sum payment as specified below.

Revised Site 413 shall be shortened as shown on the attached Drawing Mod 6, the amount of steel sheet piles, pipe piles, drainfill, and flex mat shall be adjusted as shown below. The Contractor shall mobilize and demobilize to revised Site 413 as required to complete all work as modified at the revised location, including work required to access the site.
