## **2**<sup>nd</sup> Amendment to Grant Agreement between Texas Council on Family Violence and the Fort Bend County

The Texas Council on Family Violence (TCFV) and the Fort Bend County (herein "Vendor") previously entered into an agreement related to a High-Risk Team Demonstration Project on February 26, 2020.

This is the 2<sup>nd</sup> amendment to the contract fully executed on February 26, 2020. This amendment serves to revise the contract term to support continued Domestic Violence High Risk Team services conducted by the Fort Bend County until October 31, 2021. This amendment does not include or infer additional funding from TCFV, other than what is outlined below.

Contract is amended as follows:

## TCFV Responsibilities:

A. In consideration for all Vendor services to be rendered by Vendor under this Contract, TCFV shall pay Vendor as set forth in this Contract unless delayed by availability of federal and state grant funds.

TCFV will compensate Vendor a total of \$50,000.00 in 4 installments with the following payment schedule:

I. \$12,500.00 upon full execution of this contract
II. \$12,500.00 February 1, 2021
III. \$12,500.00 May 3, 2021
IV. \$12,500.00 August 2, 2021

B. These funds originate from the Office of the Attorney General, Grant #2106755.

## **Vendor Services and Responsibilities:**

- A. Vendor will utilize existing expertise in responding to the needs and building upon the strengths of their respective communities while using the TCFV funding to support and foster additional capacity in this regard.
- B. The DVHRT coordinators will commit to attending regular teleconferences and training sessions where they share their successes, failures, and challenges with other DVHRT coordinators in order to promote best practices with other DVHRT sites.
- C. DVHRT coordinators will provide a case tracking report for statistical analysis no later than the 5th of each month for the previous month. A tracking form will be provided by TCFV, excluding any identifying information about the victim(s) or suspect(s) involved. The data gathered will serve the following purposes:
  - a. Analyze progress toward goals and objectives;
  - b. Share best practices with victims and the community as a whole; and
  - c. Serve as a learning platform for future training efforts and identify emerging issues
- D. Submission of quarterly reports are required to share information on project successes, failures, challenges, and case outcomes. A quarterly report form will be provided by TCFV. Deadlines are March 7, 2021, June 7, 2021, and October 7, 2021.
- E. Participate in any project evaluation, including onsite meetings with TCFV staff and any contract researchers.
- F. Coordinate with TCFV on any media events related to grant project.

TCFV and Fort Bend County reaffirm no other terms or conditions for the above- mentioned original contract not hereby otherwise modified or amend shall be negated or changed. All other terms of the Contract and prior amendments remain in full force and effect.

By signing this Amendment, and based on mutual consideration, both parties hereby understand and agree to the above conditions as listed. The below signatures will act as a final confirmation of both parties' agreement to amendment terms, unless discussed and agreed in writing otherwise.
