**TWELFTH ADDENDUM TO SOFTWARE AND MAINTENANCE AGREEMENT**  
**PURSUANT TO RFP 06-101**

THIS TWELFTH ADDENDUM is entered into by and between Fort Bend County, (hereinafter "Licensee"), a body corporate and politic under the laws of the State of Texas, and Trapeze Software Group, Inc., (hereinafter "Contractor").

THAT, WHEREAS, the parties have executed and accepted that certain Software and Maintenance Agreement, (hereinafter the "Agreement") on August 28, 2007, pursuant to RFP 06-101 incorporated by reference herein for all purposes; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein:

**NOW, THEREFORE,** the parties do mutually agree as follows:

1. The Maximum Compensation for the Scope of Services including reimbursable expenses shall be increased by twenty-nine thousand six hundred thirty dollars and no/100 (\$29,630.00). In no case shall the amount paid by County for the Services described in Exhibit A exceed the Maximum Compensation without written approval by both parties.
2. The term of performance shall begin on March 01, 2021 and end on February 28, 2022.
3. All terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect for the term of Agreement. If there is a conflict between this Twelfth Addendum and the Agreement for Software and Maintenance Agreement including all previous Amendments Addendums, the provisions of this Twelfth Addendum shall prevail with regard to the conflict.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
