HORTON-TEXAS, LTD., A TEXAS LIMITED PARTNERSHIP, OWNERS HERINAFTER REFERRED TO AS OWNERS OF THE 2.865 ACRE TRACT DESCRIBED IN THE ABOVE AND FOREGOING PLAT OF WALLER CROSSING DRIVE STREET DEDICATION, DO HEREBY MAKE AND ESTABLISH SAID SUBDIVISION PLAT OF SAID PROPERTY ACCORDING TO ALL LINES, DEDICATIONS, RESTRICTIONS AND NOTATIONS ON SAID PLAT AND HEREBY DEDICATE TO THE USE OF THE PUBLIC FOREVER, ALL STREETS, ALLEYS, PARKS, WATER COURSES, DRAINS, EASEMENTS AND PUBLIC PLACES SHOWN THEREON FOR THE PURPOSES AND CONSIDERATIONS THEREIN EXPRESSED; AND DO HEREBY BIND OURSELVES, OUR HEIRS AND ASSIGNS TO WARRANT AND FOREVER DEFEND THE TITLE TO THE LAND SO DEDICATED.

FURTHER, OWNERS HAVE DEDICATED AND BY THESE PRESENTS DO DEDICATE TO THE USE OF THE PUBLIC FOR PUBLIC UTILITY PURPOSES FOREVER UNOBSTRUCTED AERIAL EASEMENTS. THE AERIAL EASEMENTS SHALL EXTEND HORIZONTALLY AN ADDITIONAL ELEVEN FEET, SIX INCHES (11' 6") FOR TEN FEET (10' 0") PERIMETER GROUND EASEMENTS OR SEVEN FEET, SIX INCHES (7' 6") FOR FOURTEEN FEET (14' 0") PERIMETER GROUND EASEMENTS OR FIVE FEET, SIX INCHES (5' 6") FOR SIXTEEN FEET (16' 0") PERIMETER GROUND EASEMENTS, FROM A PLANE SIXTEEN FEET (16' 0") ABOVE GROUND LEVEL UPWARD, LOCATED ADJACENT TO AND ADJOINING SAID PUBLIC UTILITY EASEMENTS THAT ARE DESIGNATED WITH AERIAL EASEMENTS (U.E. AND A.E.) AS INDICATED AND DEPICTED, HEREON, WHEREBY THE AERIAL EASEMENT TOTALS TWENTY ONE FEET, SIX INCHES (21' 6") IN WIDTH.

FURTHER, OWNERS HAVE DEDICATED AND BY THESE PRESENTS DO DEDICATE TO THE USE OF THE PUBLIC FOR PUBLIC UTILITY PURPOSES FOREVER UNOBSTRUCTED AERIAL EASEMENTS. THE AERIAL EASEMENTS SHALL EXTEND HORIZONTALLY AN ADDITIONAL TEN FEET (10' 0") FOR TEN FEET (10' 0") BACK-TO-BACK GROUND EASEMENTS, OR EIGHT FEET (8' 0") FOR FOURTEEN FEET (14' 0") BACK-TO-BACK GROUND EASEMENTS OR SEVEN FEET (7' 0") FOR SIXTEEN FEET (16' 0") BACK-TO-BACK GROUND EASEMENTS, FROM A PLANE SIXTEEN FEET (16' 0") ABOVE GROUND LEVEL UPWARD, LOCATED ADJACENT TO BOTH SIDES AND ADJOINING SAID PUBLIC UTILITY EASEMENTS THAT ARE DESIGNATED WITH AERIAL EASEMENTS (U.E. AND A.E.) AS INDICATED AND DEPICTED HEREON, WHEREBY THE AERIAL EASEMENT TOTALS THIRTY FEET (30' 0") IN WIDTH.

FURTHER, OWNERS DO HEREBY COVENANT AND AGREE THAT ALL OF THE PROPERTY WITHIN THE BOUNDARIES OF THIS PLAT IS HEREBY RESTRICTED TO PREVENT THE DRAINAGE OF ANY SEPTIC TANKS INTO ANY PUBLIC OR PRIVATE STREET, ROAD OR ALLEY OR ANY DRAINAGE DITCH, EITHER DIRECTLY OR INDIRECTLY.

FURTHER, OWNERS DO HEREBY DEDICATE TO THE PUBLIC A STRIP OF LAND TWENTY (20) FEET WIDE ON EACH SIDE OF THE CENTER LINE OF ANY AND ALL BAYOUS, CREEKS, GULLIES, RAVINES, DRAWS, AND DRAINAGE DITCHES LOCATED IN SAID SUBDIVISION, AS EASEMENTS FOR DRAINAGE PURPOSES. FORT BEND COUNTY OR ANY OTHER GOVERNMENTAL AGENCY SHALL HAVE THE RIGHT TO ENTER UPON SAID EASEMENT AT ANY AND ALL TIMES FOR THE PURPOSES OF CONSTRUCTION AND MAINTENANCE OF DRAINAGE FACILITIES AND STRUCTURES.

FURTHER, OWNERS DO HEREBY COVENANT AND AGREE THAT ALL OF THE PROPERTY WITHIN THE BOUNDARIES OF THIS SUBDIVISION AND ADJACENT TO ANY DRAINAGE EASEMENT, DITCH, GULLY, CREEK OR NATURAL DRAINAGE WAY SHALL HEREBY BE RESTRICTED TO KEEP SUCH DRAINAGE WAYS AND EASEMENTS CLEAR OF FENCES, BUILDINGS, EXCESSIVE VEGETATION AND OTHER OBSTRUCTIONS TO THE OPERATIONS AND MAINTENANCE OF THE DRAINAGE FACILITY AND THAT SUCH ADJUTING PROPERTY SHALL NOT BE PERMITTED TO DRAIN DIRECTLY INTO THIS EASEMENT EXCEPT BY MEANS OF AN APPROVED DRAINAGE STRUCTURE.

FURTHER, OWNERS DO HEREBY CERTIFY THAT THEY ARE THE OWNERS OF ALL PROPERTY IMMEDIATELY ADJACENT TO THE BOUNDARIES OF THE ABOVE AND FOREGOING SUBDIVISION OF WALLER CROSSING DRIVE STREET DEDICATION WHERE BUILDING SETBACK LINES OR PUBLIC UTILITY EASEMENTS ARE TO BE ESTABLISHED OUTSIDE THE BOUNDARIES OF THE ABOVE AND FOREGOING SUBDIVISION AND DO HEREBY MAKE AND ESTABLISH ALL BUILDING SETBACK LINES AND DEDICATE TO THE USE OF THE PUBLIC, ALL PUBLIC UTILITY EASEMENTS SHOWN IN SAID ADJACENT ACREAGE.

FURTHER, OWNERS DO HEREBY ACKNOWLEDGE THE RECEIPT OF THE "ORDERS FOR REGULATION OF OUTDOOR LIGHTING IN THE UNINCORPORATED AREAS OF FORT BEND COUNTY, TEXAS", AND DO HEREBY COVENANT AND AGREE AND SHALL COMPLY WITH THIS ORDER AS ADOPTED BY FORT BEND COUNTY COMMISSIONERS' COURT ON MARCH 23, 2004, AND ANY SUBSEQUENT AMENDMENTS.

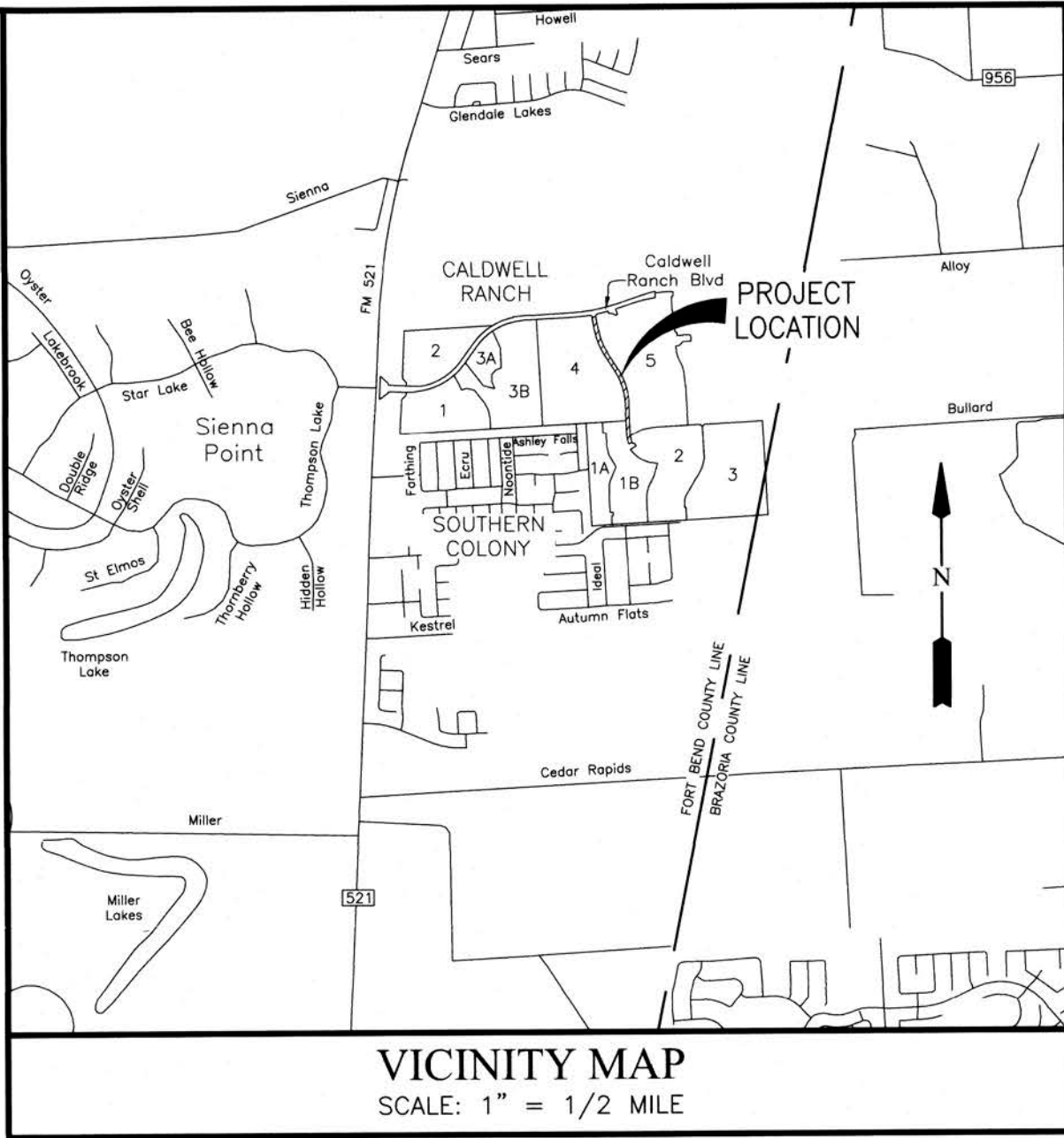
Being a tract containing 2.865 acres of land, located in the William Hall Survey, Abstract Number 31, in Fort Bend County, Texas, Said 2.865 acre tract being a portion of a call 353.926 acre tract recorded in the name of 258 Colony Investments, LLC in File Number 2019127946 of the Official Records of Fort Bend County (O.R.F.B.C.) and a portion of call 93.567 acre tract styled Tract 1 and recorded in the name of D.R. Horton-Texas, LTD. in File Number 2019129484 of the O.R.F.B.C.; Said 2.865 acre tract being more particularly described by metes and bounds as follows (bearings being based on the Texas Coordinate System, South Central Zone, NAD 83, as derived from GPS observations):

Commencing at the northwesterly corner of a call 49.946 acre tract recorded in the name of 258 Colony Investments, LLC in File Number 2019127829 of the O.R.F.B.C.;

Thence, through and across aforesaid 353.926 acre tract, South 88 degrees 59 minutes 44 seconds West, a distance of 1123.89 feet to the Point of Beginning of the herein described tract;

Thence, through and across said 353.926 acre and 93.567 acre tracts, the following fourteen (14) courses:

- 1) South 10 degrees 22 minutes 04 seconds East, a distance of 207.67 feet;
- 2) 379.57 feet along the arc of a curve to the left, said curve having a radius of 970.00 feet, a central angle of 22 degrees 25 minutes 13 seconds and a chord that bears South 21 degrees 34 minutes 41 seconds East, a distance of 377.15 feet;
- 3) South 32 degrees 47 minutes 17 seconds East, a distance of 315.02 feet;
- 4) 534.45 feet along the arc of a curve to the right, said curve having a radius of 1030.00 feet, a central angle of 29 degrees 43 minutes 46 seconds and a chord that bears South 17 degrees 55 minutes 24 seconds East, a distance of 528.47 feet;
- 5) South 03 degrees 03 minutes 31 seconds East, a distance of 511.10 feet;
- 6) 125.63 feet along the arc of a curve to the left, said curve having a radius of 370.00 feet, a central angle of 19 degrees 27 minutes 17 seconds and a chord that bears South 12 degrees 47 minutes 09 seconds East, a distance of 125.03 feet;
- 7) South 67 degrees 29 minutes 12 seconds West, a distance of 60.00 feet;
- 8) 146.01 feet along the arc of a curve to the right, said curve having a radius of 430.00 feet, a central angle of 19 degrees 27 minutes 19 seconds and a chord that bears North 12 degrees 47 minutes 09 seconds West, a distance of 145.31 feet;
- 9) North 03 degrees 03 minutes 31 seconds West, a distance of 511.10 feet;
- 10) 503.32 feet along the arc of a curve to the left, said curve having a radius of 970.00 feet, a central angle of 29 degrees 43 minutes 47 seconds and a chord that bears North 17 degrees 55 minutes 24 seconds West, a distance of 497.69 feet;
- 11) North 32 degrees 47 minutes 17 seconds West, a distance of 315.02 feet;
- 12) 403.05 feet along the arc of a curve to the right, said curve having a radius of 1030.00 feet, a central angle of 22 degrees 25 minutes 13 seconds and a chord that bears North 21 degrees 34 minutes 41 seconds West, a distance of 400.48 feet;
- 13) North 10 degrees 22 minutes 04 seconds West, a distance of 207.66 feet;
- 14) North 79 degrees 37 minutes 56 seconds East, a distance of 60.00 feet to the Point of Beginning and containing 2.865 acre of land.
