**Dear Commissioner Meyers:** 

Fort Bend County Engineering has received a request for a street name modification to change existing **Jordan Road** to **Woods Road** from the Waller/Fort Bend County line south to the 90-degree bend in Jordan Road (2.02 miles south of county line) and to change **Jordan Road** to **Fulshear Bend Drive** from the 90-degree bend in Jordan Road west to FM 359 (0.27 miles).

The reason for the name change is for continuity purposes, as Waller County has the street name as Woods Road with multiple addresses from this roadway. The portion to rename the road to Fulshear Bend Drive is in alignment with future development plans. See attachments.
