FIRST AMENDMENT TO AGREEMENT FOR AUDIT SERVICES BETWEEN WHITLEY PENN LLP AND FORT BEND COUNTY PURSUANT TO FBC RFP 20-083

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Whitley Penn, LLP (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement For Audit Services Between Whitley Penn LLP And Fort Bend County Pursuant To FBC RFP 20-083 on September 22, 2020, (hereinafter "Agreement") which is incorporated by reference;

WHEREAS, the parties desire to amend the Agreement to extend the Time of Performance and increase the total Maximum Compensation under the Agreement for the completion of such additional services to be provided thereunder;

WHEREAS, County desires that Contractor provide professional Audit Services (hereinafter "Services") pursuant to FBC RFP 20-083; and

WHEREAS, Contractor represents that it is qualified and desires to perform such services;

NOW, THEREFORE, the parties do mutually agree as follows:

- -1. County shall-pay-Contractor an additional \$45,250.00 to continue providing Services under the terms and conditions of the Agreement.
- 2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed 226,250,00, authorized as follows:

\$181,000.00 under the Agreement; and \$45,250.00 under this Amendment.

3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties. 4. The parties agree the terms and conditions of the Agreement have remained in effect to date and are hereby extended to end no later than July 31, 2023.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
