Task Project Management (CobbFendley)

- · Attended a status meeting with BBI meeting on June 15, 2021.
- Made the modification to the horizontal alignment impacted 2 curvatures in order to meet the FBC latest design criteria of 1500-ft min. R
- Prepared preliminary proposed ROW envelopes based on latest survey information.
- · Coordinated with the City of Richmond for the following:
 - Proposed outfalls and storm sewer tie-in to the Clay Street system & ongoing design of the Clay Street paving, H&B, and drainage improvements and proposed roundabout configuration intersecting Clay Street.
- Revised the KMZ file and list of impacted properties with property data & ownership due to the change in the horizontal alignment.
- Incorporated the proposed storm sewer linework into the P&P sheets based on the H&H analysis for the PER update.
- Work in progress towards identification and completion of the final utility conflicts and preparation of utility conflict table.
- Drainage report has been completed and distributed to BBI & City of Richmond for review & comments.
- Work in progress for developing a preliminary construction cost estimate.

Task: Surveying

- Supplemental topographic field survey has been completed
- Revised KMZ file and PDF copies of ROW parcels with list of the impacted parcels were distributed to BBI, FBC engineering & City of Richmond based on the refined horizontal alignment.
- CobbFendley will proceed with the proposed ROW parcels meets & bound descriptions as directed by BBI on June 23, 2021

Task: Geotechnical (Subconsultant)

Will authorize All-Terra to proceed with the Geotechnical investigation in late June

Task: PER Update

- The horizontal & vertical alignments and P&P sheets for the 10th Street are near completion and working on the intersection streets paving and drainage tie-in.
- Drainage study report completed and submitted to the City & BBI for review & comments.
- As requested by BBI, CobbFendley is preparing a proposal to conduct a public meeting for the 10th street project. The meeting schedule is to be determined by the County.
- Continue our coordination efforts with UPRR for the proposed at-grade track crossing.
- Will finalize the project schematic and cost estimate after the public meeting to conduct the PER review.
