Internally Initiated Fort Bend County Road Name and/or Address Range Change Form

It has been brought to the attention of Fort Bend County Engineering GIS that a need has arisen for the following:

- A) The naming convention of a road within the unincorporated area of Fort Bend County should be changed from **Sansbury Boulevard** to **Manford Boulevard** between Williams Way Boulevard and Grand Estates Drive located on Key Map page 606P and 606Q within the postal and zip code 77469.
- B) The address range of the road named **Manford Boulevard** within the unincorporated area of Fort Bend county should be revised to the beginning block of **5000** and ending block of **5099**. This road is located on Key Map page 606P within the postal and zip code 77469.

This matter will be presented to as an item of consideration for Commissioner's Court on **August 24, 2021**. Upon approval, all affected entities will be forwarded the documents associated with the aforementioned change.




