Fort Bend County Engineering is requesting a street name modification to change existing **Grand Mission Boulevard** to **Harlem Road** south of Beechnut Street to approximately 100-feet south of Stone Mission Lane. Grand Mission Boulevard was recorded by plat in *Bradford Park Sec 1* Instrument #20050034 and in *Grand Mission Blvd. from Bellaire Blvd to Dow Pipeline* Instrument #20060166.

The reason for the name change is to match existing conditions as currently signed and to improve emergency response in the area.

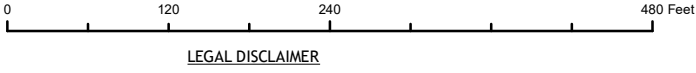


Harlem Road and

Name Change

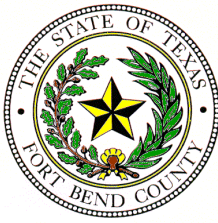

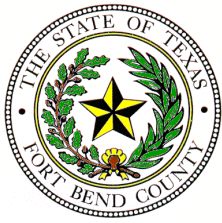
