

RESOLUTION NO. R-3113

A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF ROSENBERG, FORT BEND COUNTY, TEXAS, PROVIDING CONSENT FOR DESIGNATED PORTIONS OF THE EXTRATERRITORIAL JURISDICTION OF THE CITY TO BE INCLUDED WITHIN THE PROPOSED EMERGENCY SERVICES DISTRICT, NAMED "FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 9" TO PROVIDE EMERGENCY SERVICES FOR THE RESIDENTS RESIDING WITHIN THE DESIGNATED PORTIONS OF THE EXTRATERRITORIAL JURISDICTION OF THE CITY OF ROSENBERG, AND TO PROVIDE EMERGENCY SERVICES WITHIN THE BOUNDARIES OF THE PROPOSED EMERGENCY SERVICES DISTRICT.

WHEREAS, The City of Rosenberg has been served with a petition for a proposed Emergency Services District, named "Fort Bend County Emergency Services District No. 9", herein after referred to as "District" on June 29, 2021; and

WHEREAS, The proposed District contains territory in the City of Rosenberg's Extra Territorial Jurisdiction; and

WHEREAS, The City of Rosenberg received a written request to include portions of the City's ETJ in the District on June 29, 2021; and

WHEREAS, The City of Rosenberg City Council hereby gives written consent to include portions of the City's ETJ in the District;

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ROSENBERG:

Section 1. The City of Rosenberg received a written request to include portions of the City's ETJ in the District on June 29, 2021.

Section 2. That the boundaries of the proposed District includes portions of the Extraterritorial Jurisdiction of the City of Rosenberg.

Section 3. The City Council for the City of Rosenberg, by and through this Resolution and pursuant to Chapter 775, Section 775.014 of the Health and Safety Code, gives consent for designated portions of the Extraterritorial Jurisdiction of the City of Rosenberg to be included within the proposed District for the purpose of providing

emergency services to the residents residing within the designated portions of the Extraterritorial Jurisdiction of the City of Rosenberg and to those within the proposed District.

Section 4. A copy of the petition of the proposed District is attached hereto as Exhibit "A" and made a part hereof for all purposes.

Section 5. This resolution shall be effective immediately upon being passed and approved.

TO THE HONORABLE COUNTY JUDGE AND COMMISSIONERS OF SAID COURT:

NOW COME 100 or more qualified voters who own taxable real property in Fort Bend County, Texas pursuant to Texas Health & Safety Code, Section 775.011, requesting the creation of an Emergency Services District and would respectfully show the following:

I.

That the proposed Fort Bend County Emergency Services District No. 9 (the "District") will be created and operated under the provisions of Article III, Section 48-e of the Constitution of Texas and Chapter 775 of the Health & Safety Code of the State of Texas.

II.

That the name of the proposed District shall be "FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 9."

III.

That the area of the District does not overlap the boundaries of any other emergency services district, and will generally include all or portions of the city limits of the City of Needville and portions of the extraterritorial jurisdictions of the Cities of Needville, Rosenberg, Alvin and Fairchilds. The boundaries of the District are more particularly described by the description attached as Exhibit "A", which is attached hereto and incorporated herein for all purposes, and generally shown on the attached sketch in Exhibit "B".

IV.

The District will provide emergency services in response to any emergency situation in accordance with the authority granted to emergency services districts under Chapter 775 of the Texas Health & Safety Code.

V.

The creation of the District complies with Section 775.0205 of the Texas Health & Safety Code.

VI.

That Clay Forister, who resides at 3811 Founders Drive, Needville, Texas 77461; Keith Thumann, who resides at 9503 Highland Park Drive, Needville, Texas 77461; and Donald Vandelinder, who resides at 9050 Bowie Trail, Needville, Texas 77461 (collectively, "Petitioners"), agree and obligate themselves to pay the cost incident to the formation of the District, including the costs of publishing notices, election costs, and other necessary and incidental expenses, such cost not to exceed one hundred fifty (\$150.00) dollars, to Fort Bend County as required by Section 775.013(b) of the Texas Health & Safety Code.

VII.

The cities of Needville, Rosenberg, Alvin, and Fairchilds are the only municipalities whose consent must be obtained under Section 775.014 of the Texas Health & Safety Code.


VIII.

Description of Proposed Fort Bend County Emergency Services District No. 9

Boundary Description

Beginning at the point of intersection of the Fort Bend-Wharton County line with the southernmost corner of the boundary of Fort Bend County Emergency Services District No. 8, thence north and easterly along the boundary of Fort Bend County Emergency Services District No. 8 to the point of intersection with the boundary of Fort Bend County Emergency Services District No. 6, thence south and easterly along the boundary of Fort Bend County Emergency Services District No. 6 to the point of intersection with eastern right-of-way line of State Highway 36, thence southerly along the eastern right-of-way line of State Highway 36 to the point of intersection with the northeast right-of-way line of Jeske Road, thence south and easterly along the northeast right-of-way line of Jeske Road to the point of intersection with the northwest right-of-way line of Roesler Road, thence north and easterly along the northwest right-of-way line of Roesler Road to the point of intersection with the northeast right-of-way line of Oberrender/Zamanek Road, thence south and easterly along the northeast right-of-way line of Zamanek Road to the point of intersection with the northwestern right-of-way line of FM 1994; then north and easterly along the northwest right-of-way line of FM 1994 to the point of intersection with the northeast right-of-way line of Davis Estate Road extended across FM 1994; thence easterly along the north right-of-way line of Davis Estate Road to the point of intersection with the west right-of-way line of Tadpole Road/County Road 762; thence northerly along the west right-of-way line of Tadpole Road/County Road 762 to the point of intersection with the north right-of-way line of Sawmill Road extended across Tadpole Road/County Road 762, thence easterly along the north right-of-way line of Sawmill Road to the point of intersection with the north property line of that certain 2188.48 acre tract owned by the State of Texas in the Barrett & Harris Survey and known as Brazos Bend State Park, thence easterly along the north boundary line of Brazos Bend State Park to the Fort Bend-Brazoria County Line, thence southerly and westerly along the Fort Bend-Brazoria County Line to the point of intersection of the Fort-Bend Brazoria County Line with the Fort Bend-Wharton County Line; thence north and westerly along the Fort Bend-Wharton County Line to the point of beginning.

Fort Bend County Emergency Services District No. 9




