

Progress During This Billing Period:

### TEDSI:

- Coordination with Fawzi Abou-Hossa of TxDOT on project progress.
- Submitted the Design Concept Conference (DCC) forms and received comments on the Design Summary Report (DSR) from Fawzi.
- Submitted roll plots of the conceptual TCP to Fawzi and requested a meeting to for a 30% TCP workshop. The TCP Workshop is now scheduled for October 7<sup>th</sup>.
- Received direction of from TxDOT to revise the 14' outside lane to a 12' lane and add in a 10' sidepath. Confirmed offset required is 5' from face of curb. Prepared exhibits to detail limited ROW and sound wall conflicts where only 8' sidepath will fit.
- Still requested mainlane Drainage Report to prepare 60% drainage plans. Met on September 17<sup>th</sup> with RPS, Civiltech, DEC, SPI to discuss drainage. Still have not received the Drainage Report.
- Continued working on all sheets for Title Sheet, Existing Typical Sections, Proposed Typical Sections, Roadway Plan & Profiles, Retaining Wall Plan & Profiles, TCP narrative and conceptual phasing layouts.
- Continued working on the preliminary traffic sheets including signal modification, signing and pavement marking.
- Submitted the 60% PS&E on September 16<sup>th</sup>.
- Updated preliminary cost estimate with accurate quantities.
- Submitted electronic copy and hard copy of the final Geotechnical Report.
- Submitted electronic copies of all ROW mapping documents. TxDOT requested hard copies of all ROW documents.
- General coordination with subconsultants, design team leaders, project management, invoice and progress reporting.
