Yes sir, I am more than happy to help in any way that I can. We had a blood program but for our model, we just weren't using blood as often as we thought that we might. When we started having shortages in the supply chain, we made the decision to pause the program and have now decided to leave it on the shelf.

I have 4 Bloodboxx coolers that are capable of holding 3 units of blood. You guys would need to get the actual freezer packs from BloodBox because the ones that I have are expired (they are not expensive at all). We bought 3 sets of freezer pouches for the BloodBox's and labeled them A/B/C shift. This allowed the guys to rotate their shifts packs onto the truck and ensured that the packs had been in the freezer at least 24 hours prior to being pulled. To facilitate that we had deep freezers in the stations that were only there to condition the packs. I have 4 of the deep freezers that are about the size of a small dorm fridge. I believe the internal storage space is 1.5cuft. There's also some sensor push stuff that I haven't laid my hands on yet, but you guys are welcome to everything that we have if somebody can pick it up.

I believe in blood programs and I absolutely believe that it will save lives so helping you guys get your program up and off the ground feels like the better option than having all of this sitting in a closet. Let me know if you have any questions, I sent Kavon pictures but I can send more if you need them.
