**NOTICE IS HEREBY GIVEN THAT A TAX ABATEMENT AGREEMENT WILL BE PRESENTED TO THE FORT BEND COUNTY DRAINAGE DISTRICT FOR APPROVAL AT AN UPCOMING REGULAR MEETING OF THE DISTRICT WHICH WILL BE HELD NO SOONER THAN 30 DAYS FROM THE DATE THIS NOTICE WAS FILED WITH COUNTY CLERK.**

FOR THE TAX ABATEMENT AGREEMENT TO BE PRESENTED APPEARS BELOW:**

- (1) Cutlass Solar II, LLC is the company name for the new or modified agreement.
- (2) The project is within Fort Bend County Reinvestment Zone 23 in Precinct 2, Fort Bend County. The project is located off the northwest corner of FM 1994 and FM 361, Fort Bend County , Texas.
- (3) The improvements for the property are as follows: Several small buildings to support operations of a major solar energy generation facility.
- (4) The estimated cost of the improvements or repairs: Eligible Improvements will be a minimum of \$138,000,000
- (5) Additional significant Project Details or Values/Costs: <sup>1</sup> Eligible Personal Property shall be a minimum of \$2,000,000. The greater value of the project lies in the Eligible Personal Property comprising the overall plant facility. \$140,000,000.

This public notice is being posted at least 30 days before the scheduled time of the meeting. The Abatement Agreement will appear on the Notice of Meeting that will be issued for the actual scheduled meeting which will include the meeting date and be posted in the manner required by Chapter 551, Government Code.
