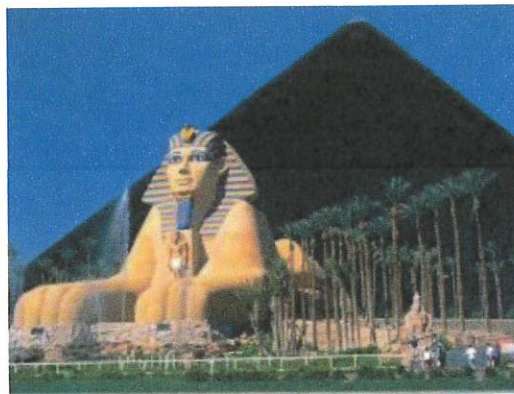

The state of Nevada re-imposed a mask mandate in late July following guidance from the CDC regarding the Delta variant of COVID-19, which is still in effect. **Masks must be worn inside the Luxor at all times (except when eating)**. This directive applies to everyone in public indoor settings in the state of Nevada regardless of vaccination status. This includes visitors, employees, meeting organizers, exhibitors and meeting attendees. Masks are not required at outdoor venues.

PBUS™ will hold a membership meeting on **Monday, February 21, 2022** in the afternoon and it will be reconvened on **Wednesday, February 23, 2022** for the elections; changes to the by-laws may be made. Candidate Forum and Luncheon:

A Candidate Forum will be held the day prior to the elections, **Tuesday, February 22, 2022**, for the purpose of allowing candidates who are opposed to make a campaign statement; the Forum will commence after the luncheon concludes. Presidential candidates will be given three minutes for comments to the membership; other candidates facing opposition will be given two minutes for comments to the membership. Unopposed candidates will be introduced only. Election Information:

Elections will be held on **Wednesday, February 23, 2022** for a new PBUS™ Board of Directors. After the second call, the membership meeting will be recessed until it is reconvened on **Wednesday, February 23, 2022**, at which time the **third call** will occur and nominations will be closed and the election held. 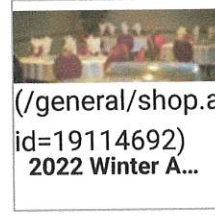
PBUS Poker Tournament:
