EIGHTH AMENDMENT for RENEWAL OF PROFESSIONAL SERVICES AGREEMENT FOR INTELLIGENCE ANALYSTS

THIS Eighth Amendment for Renewal of Professional Services Agreement, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and The Kace Company, LLC., formerly known as MVM, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Professional Services Agreement for Intelligence Analysts between Fort Bend County and MVM, Inc. on or about December 9, 2014, and as subsequently amended on October 6, 2015, September 13, 2016, September 26, 2017, October 2, 2018, July 23, 2019, October 1, 2019, and last amended on October 27, 2020, (hereinafter "Agreement"), incorporated by reference herein for all purposes; and

WHEREAS, the Sheriff's Office has received grant funding for Intelligence Analyst Services for 2021 under the High Intensity Drug Trafficking Areas (HIDTA) Program Grant: G19HN0010A; and

WHEREAS, County desires that Contractor provide professional services for the Sheriff's Office (hereinafter "Services"); and

WHEREAS, the Agreement is expressly contingent upon funding from this HIDTA grant which shall be used for the payment of Services as described in the Agreement; and

WHEREAS, the parties desire to renew and amend the tern of performance for Services; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement and are incorporated by reference in the same as if fully set forth verbatim herein:

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. The Agreement is hereby renewed for an additional one-year period beginning on October 1, 2021 and will terminate on September 30, 2022.
- 2. The number of Employee's shall be decreased to two (2) Intelligence Analysts, with the addition of one (1) Executive Assistant/Assistant Trairing for a total of 3 employees.
- 3. The Maximum Compensation for the Scope of Services for the term ending on September 30, 2022 including reimbursable expenses shall be two hundred eighty thousand dollars and no cents (\$280,000.00). In no case shall the amount paid by County for Scope of Services exceed the Maximum Compensation without a mutually agreed upon change in writing.

All terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect for the term of the Agreement. If there is a conflict between this Amendment and the Agreement for Professional Services Agreement for Intelligence Analysts, the provisions of this Amendment shall prevail with regard to the conflict.
