That the Company has not received any claims or notice of claims from the subcontractor, materialmen and suppliers.

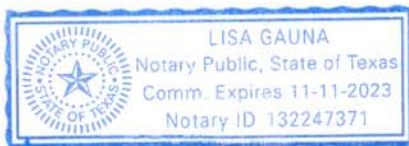
