**THIRD AMENDMENT TO  
MASTER AGREEMENT FOR CONTINGENCY RESTORATION SERVICES FOR  
EMERGENCY DISASTERS FOR FORT BEND COUNTY  
RFP 19-015**

THIS THIRD AMENDMENT is made and entered into is entered into by and between Fort Bend County, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Blackmon Mooring of Texas. Inc., (hereinafter "Contractor") a company authorized to conduct business in the State of Texas.

W I T N E S S E T H

WHEREAS, County and Contractor executed the MASTER AGREEMENT FOR CONTINGENCY RESTORATION SERVICES FOR EMERGENCY DISASTERS FOR FORT BEND COUNTY RFP 19-015 on or about JUNE 11, 2019, and as amended on or about April 7, 2020, and last amended on or about March 9, 2021 (collectively the "Agreement"), which is incorporated by reference as if set forth herein verbatim. County and Contractor desire to amend said Agreement as set forth below:

- A. The Agreement is hereby renewed; effective APRIL 1, 2022 and shall terminate on MARCH 31, 2023. Terms, conditions, pricing and additional renewal periods shall remain the same.
- B. The Parties agree that for Services provided during the 2022-2023 service year, that the total not to exceed amount shall be one million dollars and no/100 (\$1,000,000.00).
- C. Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
- D. If there is a conflict among documents, the most recently executed document will prevail with regard to the conflict.
- E. Certain State Law Requirements for Contracts: The contents of this Section are required by Texas Law and are included by County regardless of content.
  - 1. Agreement to Not Boycott Israel Chapter 2271 Texas Government Code: By signature below, Contractor verifies Contractor does not boycott Israel and will not boycott Israel during the term of this Agreement.
  - 2. Texas Government Code Section 2252.152 Acknowledgment: By signature below, Contractor represents pursuant to Section 2252.152 of the Texas Government Code, that Contractor is not listed on the website of the Comptroller of the State of Texas concerning the listing of companies that are identified under Section 806.051, Section 807.051 or Section 2252.153.

- F. Human Trafficking. BY ACCEPTANCE OF CONTRACT, CONTRACTOR ACKNOWLEDGES THAT FORT BEND COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS


