Dear Commissioner:

At the request of the Aliana Management District, Fort Bend County Engineering Department has completed the traffic control plan to prohibit parking on both sides of:

- Clouston Avenue between West Bellfort and West Aliana Trace Drive
- Somerled Avenue between SH 99 and Clouston Avenue
- Manderston Avenue between SH 99 and West Aliana Trace Drive
- Peninver Avenue between SH 99 and Clouston Avenue
- Tollcross Avenue between SH 99 and Clouston Avenue
- Hillhead Avenue between West Airport Boulevard and Clouston Avenue

This prohibition will be in effect all day. The public hearing date for acceptance for the plan will be scheduled on the next available Commissioner's Court Agenda.








Speed Limit 30 mph
