KNOW ALL MEN BY THESE PRESENTS:

Power of Attorney

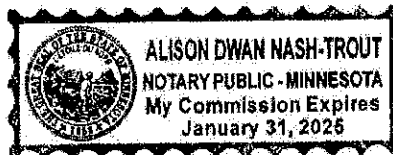
