## Task Project Management (CobbFendley)

- Completed 70% Design drawings and submitted to BBI for review & comments
- Finalized design for proposed driveway(s) and fuel truck access from proposed 10<sup>th</sup> Street onto Brazos Gas Station at the intersection of 90A
- M&B descriptions for proposed ROW parcels have been completed & submitted to BBI.
- Continuing Coordination with the City of Richmond to avoid various W & WW utility conflicts and developing solution to minimize the cost.
- Continuing UPRR railroad coordination through the City of Richmond. We will be notified by the city for their next meeting with UPRR.

### Task: Surveying

- CobbFendley completed the M&B descriptions and parcel sketches per approved proposed alignment and ROW envelope.
- Responding to BBI comments on M&B instruments as they become available.

#### Task: Geotechnical (Subconsultant)

• The geotechnical report received, pavement design recommendations were implemented, and shown on typical sections.

# Task: Design Update

- Completed & submitted 70% design plans and work in progress for producing 95% completed plan set.
- Continue coordination efforts with the City of Richmond the proposed at-grade track crossing.

#### Task: Current & Anticipated efforts

- Continue design production efforts towards 95% completed plan submittal in Late May 2022 upon receiving stakeholders' comments.
- Continue RR coordination efforts with City of Richmond for the proposed at-grade track crossing.
