KNOW ALL MEN BY THESE PRESENTS:

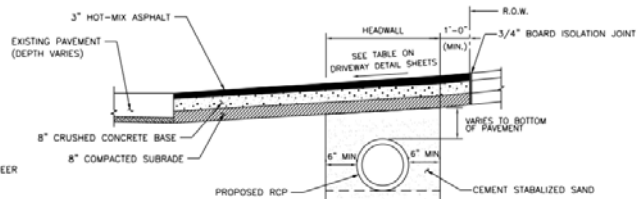




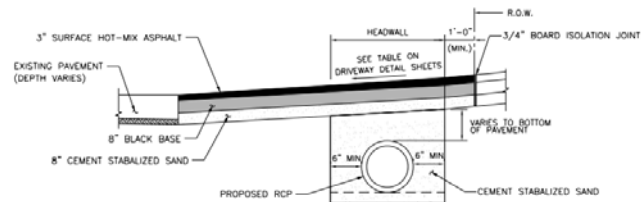
	MINIMUM RADIUS REQUIREMENTS - DRIVEWAYS

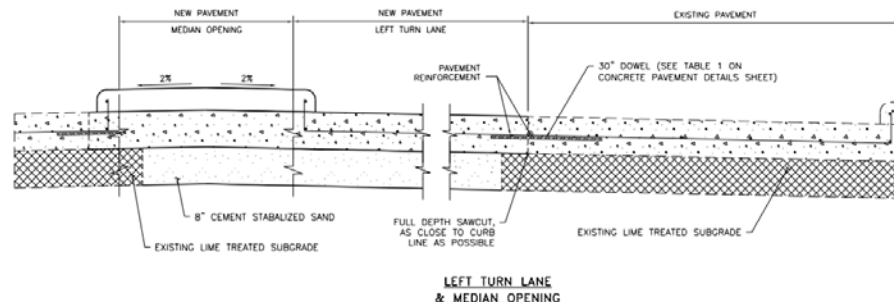
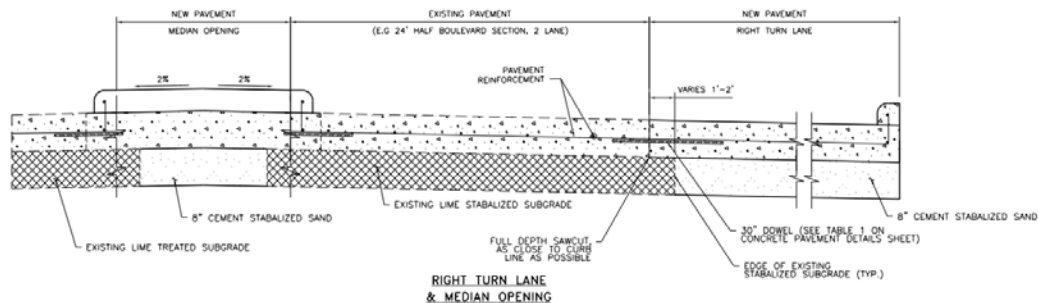
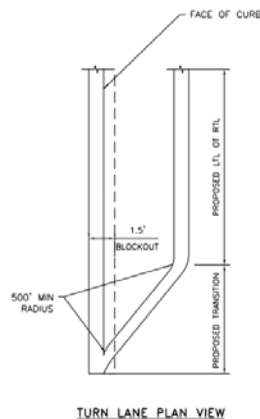
