#### **Proposal Abstract**

The Fort Bend County Sheriff's Office (FBCSO) is seeking funding in the amount of \$490,652.61, through the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, Prosecuting Cold Cases with DNA. The funding will be used for investigations of violent crime cold cases using DNA and expand the department's capacity to investigate and prosecute violent crime cold cases. According to the Federal Bureau of Investigations (FBI), in 2019, the estimated number of violent crime offenses was 1,203,808, a decrease of 0.5 percent from the 2018 estimate. The violent crime of murder and nonnegligent manslaughter increased 0.3 percent in 2019 when compared with the 2018 estimate. The murder rate was 5.0 per 100,000 inhabitants in 2019. FBCSO had a total of 8 homicides in 2020 and 15 homicides in 2021, this is an 87.5% increase in homicides. Aggravated assaults totaled 306 in 2020 and increased to 357 in 2021, Robbery totaled 124 in 2020 and 118 in 2021, and sexual assaults totaled 231 in 2020 and 224 in 2021.

It is the mission of persons employed by the Sheriff's Office of Fort Bend County to protect the lives, property, and rights of all people in this County. In accomplishing this mission, Sheriff's Office employees shall be, at all times, courteous, impartial, and diligent. One way of fulfilling this commitment is to enhance our Criminal Investigations Division by dedicating personnel, their expertise, and funding to solve and prosecute violent crime cold cases. This grant will enable FBCSO to effectively prioritized cases with suspect DNA, submit DNA for timely analysis, and successfully investigate and prosecute the case. FBCSO personnel has reviewed and accounted for 75 violent crime cold cases.

Examining and submitting existing or developed sample evidence for DNA testing in combination with the CODIS database, affords the best opportunity to re-evaluate and actively investigate these cases. This initiative will be in partnership with the Fort Bend County District Attorney's Office, Fort Bend County Municipal police departments, Texas Rangers Company A, Intermountain Forensics, Harris County Institute of Forensic Science (HCIFS), Fort Bend County

Medical Examiner's Office, 1exas State Crime Laboratory and University of North 1exas (UN1) Center for Human Identification. Additional labs, Forensic Investigative Genetic Genealogists (FIGG), Cold Case Solutions, Astrea lab, Parabon Nanolab will be utilized as needed.


