Guaranteed long life incandescent and fluorescent lamps have a life rating from 5000 to 40,000 hours depending on the types of lamps and service for which they are designed.

All long life incandescent lamps are guaranteed for a period of 12 months.

All long life fluorescent lamps are guaranteed for a period of 24 months.

High intensity discharge lamps: Mercury Vapor, Metal Halide, and Sodium Vapor, are guaranteed for a period of 12 months.

Long life quartz iodine lamps are guaranteed for a period of 12 months.

THE ABOVE WARRANTY DOES NOT APPLY TO:

- Studio and protection lamps.
- Lamps manufactured by GE, Phillips, or Sylvania that do not have a life rating of at least 3000 hours.
- Burnouts due to lamps used under abnormal conditions, faulty wiring or equipment, or defective ballasts or starters.
- Should payments not be made according to invoice terms.

TERMS AND CONDITIONS

1. Highlights of Houston, hereby gives notice of its objection to any different or additional terms and conditions. This offer to sell is expressly conditional to Buyer's assent to the terms and conditions of the front and back of this form and on approval of Buyer's credit worthiness. If not previously given, Buyer's receipt of goods is conclusive as to this assent.

Unless different or additional terms and conditions are stated or referred to in the Seller's proposal, in which event such different or additional terms and conditions shall be exclusive as to the particular subject covered, the terms and conditions stated below apply, and such terms and conditions supersede any prior or contemporaneous agreements or correspondence between parties.
2. All monies are to be paid to Highlights of Houston, Inc. only.
3. The purchaser agrees that this is a bona fide order and is not subject to cancellation. This order may only be canceled by the Buyer if agreed to by the Seller and upon payment of reasonable charges based upon expenses already incurred and commitments made by Seller.
4. A minimum service charge of 15% will be deducted on all merchandise returned. Credit for return of specialty non-stock items will be in accordance with the manufacturer or supplier and may bear additional restocking charges.
5. All offers to sell are made F.O.B. point of shipment, and each shipment, delivery or installation shall be considered a separate and independent transaction. Buyer shall assume risk of loss after F.O.B. point.
6. If in Seller's judgment, the financial condition of the Buyer at any time does not justify the terms of payment specified, Seller reserves the right to require full payment in cash before order entry, manufacture, shipment, delivery or installation.
7. Seller, its contractors, and suppliers of any tier shall not be liable in contract, in tort (including negligence or strict liability) or otherwise for damage or loss of other property or equipment, loss of profits or revenue, loss of use of equipment or power system, cost of capital, cost of purchased or replacement power or temporary equipment (including additional expenses incurred in using existing facilities), claims of customers to the Buyer, or for any special, indirect, incidental or consequential damages whatsoever.
8. The prices shown do not include any sale, use or other taxes or charges, payable to state or local authorities. Any such taxes or charges now or hereafter imposed with respect to sales or shipments hereunder will be added to such prices and the Buyer agrees to reimburse Seller for any such taxes or charges.
9. Payment due according to the terms stated on the front of this form. All credit card payments are subject to an additional 4% processing fee.
10. No sales representative of Seller has authority to alter, vary, or waive any of the standard terms and conditions herein.
11. In the event the Buyer defaults in payment, Buyer shall be liable for all collection costs incurred by Seller, including, but not limited to, attorney and collection agency fees.
