### Justification

Phone Recording Adapters: The phone recording adaptors are used to record phone calls with witnesses, victims and suspects onto our county-issued digital voice recorders. These interviews and conversations have evidentiary value and must be preserved for the investigation and prosecution of criminal allegations. They are also potentially discoverable by defense counsel.

Disk Duplicators: We need to replace several existing duplicators that are over 10 years old and subject to breakdown or mechanical failure. Additionally, with the expansion of our Investigations Division over the last few years, not every investigator has one. Duplicators are used to quickly copy disks containing digital evidence without bogging down a computer – most of which no longer come with disk drives. Copies of this evidence is usually provided to defense counsel as part of the State's discovery obligations.

Flash Drives: Digital technology is constantly evolving, and USB flash drives are the most consistent format utilized by personal computers, laptops and other devices for accessing records on external media. These devices have more storage capacity and less possibility of incurring damage (scratches, etc.) than CD's or DVD's. The digital files include dash camera, body camera, and surveillance camera footage, plus 911 calls, witness interviews, photographs, and voluminous documents.

All data copied to these drives are relevant to case investigations and become a permanent element of the case file throughout the life cycle of a case. Furthermore, when discoverable evidence is copied to an external digital media, an exact copy must be provided to defense counsel. Thus, at least two external storage devices are utilized for each corresponding criminal case.

Blu-ray player/burner: As technology advances, so do the mediums evidence is stored on. Digital media is preserved on CDs, DVDs, flash drives, and Blu-ray disks. Various mediums store differing amounts of data and we now receive evidence from law enforcement in all formats. We need to maintain an operational advantage by being able to access this media when in a Blu-ray format.

Our office routinely copies files for use in courtroom presentations and storage of evidence. Our requests enable our investigators to be mobile and provide quick access to critical information as they perform timely and comprehensive investigations, thereby allowing them to perform their responsibilities in an efficient and effective manner. 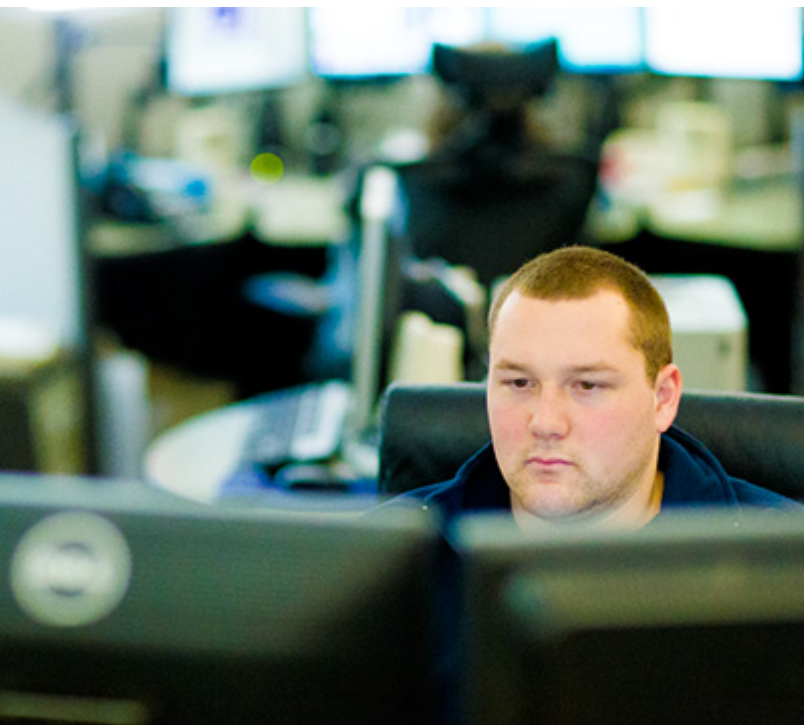



Using funds from our original budget, we have purchased "Stop Bleed" kits, which will be placed in the bag along with rifle resistant ballistic armor in addition to the items being requested via JAG. The requested items through JAG along with the items our agency has purchased through the original budget funds will complete a necessary "Go-bag". The "Go-bag"/Viktos Upscale XL Sling Bag as mentioned above, will provide quick access to essentials for our deputies to be utilized in a critical incident to render aid, provide additional resistance to the attack/attacker, and provide an additional level of protection to the deputy's armor. Further items not mentioned, which will be purchased to place in the Viktos Upscale XL Sling bag will be but not limited to; flex-cuffs, safety glasses, multi-tools, etc.

The Viktos Upscale XL Sling bag has an ambidextrous design for quick access to the several interior and exterior compartments. The bag also has a padded a padded shoulder strap for added comfort and a rugged exterior for years of use. (See attachments for further details)

The Magpull Pmag's provide additional storage for ammunition, which is vital during a crisis incident where gun fire is exchanged. With mass shootings on the rise, the need for additional ammunition which is readily available during the incident, will hopefully provide the deputy with the necessary advantage should they need it. The EM1 5-1 Lifesaver Hammer features a seatbelt cutter, striking hammer to shatter windows, needles to deflate airbags, flashlight, and a whistle. This invaluable and multi-use tool will be readily available for the deputy to utilize should they need to break a window or a door for entry in rescue scenarios, or to gain access to needed areas during critical incidents.
