The request has been placed on the 07/12/2022 agenda to set the public hearing. If you have any questions please do not hesitate to call.

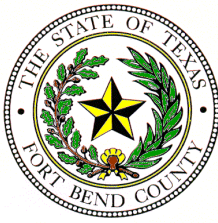

Change Form

It has been brought to the attention of Fort Bend County Engineering GIS that a need has arisen for the following:

- A) The naming convention of a road within the unincorporated area of Fort Bend County should be changed from Tayrns Way to West Firethorne Road located on Key Map page 483Q within the postal and zip code 77494.
- B) The address range of the road named Tayrns Way within the unincorporated area of Fort Bend county should be revised from the beginning block of 100 and ending block of 199 to the beginning block of 2900 and ending block of 2999. This road is located on Key Map page 483Q within the postal and zip code 77494

The purpose for this change is:

- A. To revise a street name that exists only north of Tamarron Crossing to the plat boundary of Tamarron Section 9 (20150023)
- B. For improved driver awareness of changing street names
- C. To increase 911 response times

This matter will be presented to as an item of consideration for Commissioner's Court on July 12, 2022. Upon approval, all affected entities will be forwarded the documents associated with the aforementioned change.

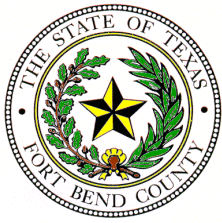

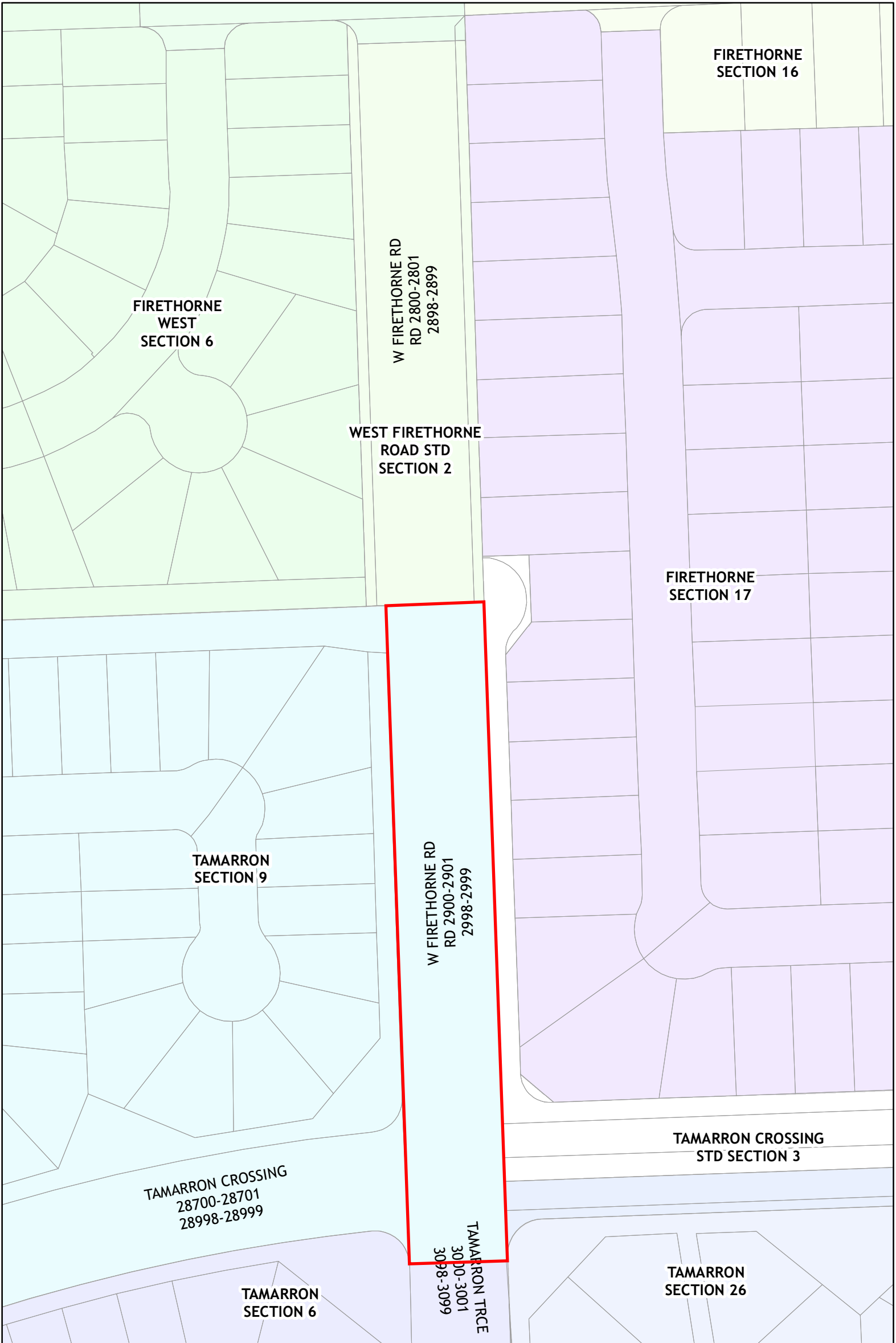
