




Course Description:

This course will provide grant applicants and sub-applicants the knowledge to develop and submit Hazard Mitigation Assistance (HMA) applications.

Course Goal:

Upon completion of this course, participants should be able to identify eligible mitigation planning and project activities and develop quality applications for the HMA grant programs. This course will provide clear instruction and group activities that will educate the student on all phases of a grant from mitigation activity identification through application and award. It will further provide detailed instruction on the principals of project management to ensure the student is equipped to properly manage the grant during the implementation phase.

Prerequisites:

Required: IS-393.a, Introduction to Hazard Mitigation, IS-212, Introduction to Unified Hazard Mitigation Assistance.

Recommended: E/L0276, Benefit-Cost Analysis.

Continuing Education Units (CEU's):

EMI awards 2.8 CEUs for completion of this course.

Target Audience:

This course is intended for local jurisdictions, tribal governments, non-profit organizations, state, FEMA employees, and public or private sector organizations that offer consulting services to Unified HMA grant applicants.

To Apply:

Complete a FEMA Form 119-25-1, General Admissions Application, with student signature and signature of supervisor or sponsoring agency official. Submit the application through the State Emergency Management Training Office. FEMA Regional employees should submit their application to their Regional Training Manager (RTM). Tribal representatives can submit their application directly to NETC Admission Office. Tribal government representatives or Federal government employees DO NOT need to submit applications through the State Emergency Management Training office or FEMA Regional Office. Travel Authorizations:

PFT and CORE employees must ensure their travel authorization (TA) is completed through Concur Government Edition (CGE) Travel System for course offerings.

Notice to Applicants for EMI courses:

Individuals applying for EMI classes will be required to register using the FEMA Student Identification (SID) number. This number will be

used in place of the Social Security Number (SSN) on your application form. **The SSN is no longer required.**

How do I obtain my FEMA SID number?

1. To register, go to <https://cdp.dhs.gov/femasid>
2. Click on the “Register for a FEMA SID” button on screen.
3. Follow the instructions and provide the necessary information to create your account.
4. You will receive an email with your SID number. You should save this number in a secure location.

NATIONAL EMERGENCY TRAINING CENTER (NETC) CAMPUS ACCESS – REAL ID ACT STANDARDS

Does your ID meet the Real ID Act standards? Anyone entering the National Emergency Training Center (NETC) campus is required to show valid photo identification that meets [REAL ID Act standards](#). The purpose of the REAL ID Act is to stop terrorists from evading detection by using false identification. Check to see if your state is compliant at <https://www.dhs.gov/current-status-states-territories>.

If your driver's license does not meet the requirements of the REAL ID Act, you will need to bring one of the following acceptable forms of identification:

- A valid U.S. passport or passport card.
- A valid federal employee, military, or veteran ID card.
- A valid state-enhanced driver's license (Contact your state's motor vehicle department for availability).

Students from non-compliant states (a regular driver's license from these states will not be accepted) who do not possess any acceptable form of identification may request a National Crime Information Center (NCIC) check from the NETC Security Office. Note: This is a one-time NCIC check; a successful NCIC check is valid for 180 days; within the 180 day time-frame a student is expected to obtain a compliant form of identification).

Submit the following information to Jason.Cawthon@fema.dhs.gov in a password-protected document at least three weeks before your class:

- Your full name
- Date and place of birth
- Social Security Number

Students arriving at the NETC campus without a compliant ID or a successful NCIC criminal history check will be sent home at their own expense without receiving a stipend reimbursement.
