KNOW ALL MEN BY THESE PRESENTS:

THAT WE, Traffic Systems Construction, Inc. whose (address, phone) is P. O. 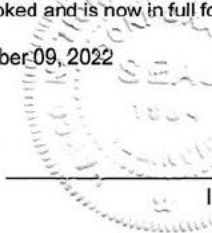
