THIRD AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENVIRONMENTAL SERVICES

THIS THIRD AMENDMENT is made and entered into by and between Fort Bend County (“County”), a body corporate and politic under the laws of the State of Texas, and SWCA, Inc. (“Contractor”), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties have executed and accepted that certain Agreement for Professional Environmental Services (the “Agreement”), on or about January 12, 2021, pursuant to RFQ 20-109, as amended on May 13, 2021 and March 22, 2022 (the “Amendments”); and WHEREAS, County desires that Contractor provide additional environmental review services pursuant to RFQ 20-109; and

WHEREAS, the Agreement is incorporated by reference, as if fully set forth verbatim herein;

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. Maximum Compensation.** The Maximum Compensation for the Scope of Services including reimbursable expenses shall be increased by **Forty Thousand dollars and 00/100 (\$40,000.00)** bringing the new Total Maximum Compensation to **One Hundred Twenty thousand dollars and 00/100 (\$120,000.00)**. In no case shall the amount paid by County for Scope of Services exceed the Maximum Compensation without an approved Amendment.
- 2. Time of Performance.** This Third Amendment shall become effective immediately upon execution by the County and will continue in full effect until March 31, 2023.
- 3. Notice.** Each party giving a Notice shall address the Notice to the receiving party at the address listed below or to another address designated by a party in a Notice pursuant to this Section:
