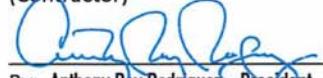
Voss Rd Turning at SH 6 Right Turn Lane

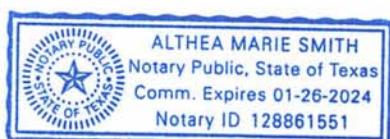
