FOR THE TAX ABATEMENT AGREEMENT TO BE PRESENTED APPEARS BELOW:**

- (1) Fort Bend Solar LLC is the company name for the new or modified agreement.
- (2) The project is within Fort Bend County Reinvestment Zone 21 in Precinct 1, Fort Bend County. The project is generally located off the northeast corner of US90A and Tavener Rd (FM1489) in the Tavener community, Fort Bend County, Tx.
- (3) The improvements for the property are as follows: Several small buildings to support the operations of a major solar energy generating facility.
- (4) The estimated cost of the improvements or repairs: Eligible Improvements will be a minimum of \$1,146,000.
- (5) Additional significant Project Details or Values/Costs: ¹ The Eligible Personal Property shall be a minimum of \$200,154,000.


