BILLS PAID AFFIDAVIT

BEFORE ME, the undersigned authority, on this day personally appeared Weston Ulbricht,

known to me to be a credible person and officer of Main Lane Industries, Ltd., a Texas Limited Partnership (hereinafter called "Contractor"), and who, being duly sworn, upon his oath declares and acknowledges as follows:

I am the duly authorized agent for the said Contractor which has authorized me to make this affidavit and all of the recitations herein are true and correct.

Pursuant to an agreement dated 10/26/2021 between Fort Bend County and Main Lane Industries, Ltd., Contractor has supplied materials and performed labor in connection with the construction of Improvements upon certain real property owned by the Owner in Fort Bend County, Texas. Said Improvements are more particularly described as 17314x Cinco Ranch Turn Lanes at SH99 in Fort Bend Co. Texas (the "Improvements").

Contractor has actual knowledge that all bills owed by Contractor to others for materials supplied or labor performed in connection with the Improvements have been fully paid and satisfied except for contractual retainage as set out below. Contractor does further warrant that should any claim or lien be filed for material supplied or labor performed by virtue of Contractor's participation in the construction of said Improvements, Contractor will immediately furnish a bond pursuant to Texas Property Code, Sections 53.236 through 53.238, for release of each such lien, and obtain settlement of any such liens and furnish Owner written full release of such liens. Should Contractor be unable to obtain such release, Contractor agrees to fully indemnify and hold harmless the Owner for any and all costs they may incur by reason of such liens.

EXCEPTIONS. The Contractor specifically excepts from this affidavit its right entitlement to payment of retainage in the amount of \$75999.18, said retainage to be due and payable to Contractor upon Owners acceptance of the Improvements and retainage to subcontractors to be paid by Contractor upon receipt from Owner.
