## **Project Abstract:**

The Fort Bend County District Attorney's Expedited Forensic Testing Project will reimburse expenses associated with expedited forensic testing for specialized cases including narcotics cases on the Expedited Narcotics Docket (END), substance abuse cases on the Drug Court (CARD), and systematic toxicology analysis (STA) in adult sexual assault cases where investigators suspect that a drug facilitated crime has taken place, and DNA testing for adult sexual assault cases. Drug Court (CARD): The Fort Bend County Drug Court is a collaborative effort of the bench, bar (prosecution and defense), probation department, treatment providers and law enforcement. This Court is designed for moderate to high risk offenders charged with a felony offense and the underlying circumstances of the offense involve substance abuse. Upon entering the program, these voluntary participants are screened by probation through lab testing then enter a three phase Drug Treatment program ehich gives addicts a chance to learn skills to control their illness and build a better life as a drug free individual. Once the defendant siuccessfully completes the program, the State will dismiss their case. CARD's caseload from 10/1/2021 until 9/30/2022 was 83 clients. The current wait for DPS lab tests is 18 months. For cases on these dockets, we send seized contraband to NMS for expedited qualitative testing using gas chromatography. Each test costs \$213 per test. We anticipate 15 pieces of seized contraband will need qualitative testing. END Docket: The Fort Bend County Board of District Judges approved a direct file order that puts low-level narcotics cases (State Jail Felony, 3rd Degree) on a compressed timetable for disposition by utilizing a specialized docket to speed up dispositions of these cases to include a 90-120 day tailored treatment plan for defendants. The desired outcome is to move small drug cases (with defendants more amenable to treatment) to a quicker disposition to clear dockets to make room for for higher-degree felony cases like sexual assault, robbery, or capital murder. If the defendant will not accept the treatment option, the judge will send the case and it's associated lab report back to the original district court for a traditional docket setting. The Systemic Toxicological Analysis Project will focus on adult sexual assault cases in the Special Crimes Division where either the victim demonstrates signs or behaviors that indicate a drug facilitated sexual assault took place or evidence gathered either at the scene and/or from the alleged perpetrator points to the possiblity that a drug facilitated sexual assault actually took place. The Fort Bend District Attorney's Office utilizes the Texas Department of Public Safety (DPS) for toxicology testing. DPS's toxicology testing has limitations, not only in the time it takes for toxicology testing, but also in what substances they are able to test for. Two commonly used drugs in drug-facilitated sexual assaults are Gamma-hydroxybutyrate (GHB) and gamma-Butyrolactone (GBL). Both GHB and GBL are metabolized in the body as GHB. Texas DPS toxicology testing is not able to test for or detect the presence of GHB in blood or urine samples. However, NMS Laboratories has a specific toxicology test, a Drug Facilitated Crime Panel, which is able to test for and detect GHB in blood and urine samples. The cost of the NMS Drug Facilitated Crime Panel is \$505.00 per sample.

## **Problem Statement:**

We cannot reasonably move these smaller drug possession cases to a disposition (either plea or trial) without a lab test. The Texas Department of Public Safety Crime Lab typically takes 12-18 months to return results. By the time we receive results from DPS, the window of opportunity has closed to get willing defendants to a quick disposition with tailored treatment options on the Expedited Narcotics Docket and the Drug Court (CARD). The backlog of small possession cases will continue to clog district court dockets and divert resources away from crime victims with cases that carry higher degree felony charges. The need for systematic toxicology analysis is critical in sexual assault cases where investigators suspect a drug facilitated crime has occurred. Current resources for this type of testing through Texas DPS are limited due to the 12-18 month backlog of cases. In addition, the DPS crime lab is unable to test blood or

urine for the presence of compounds typically used in drug facilitated sexual assaults such as GHB, Ketamine, and MDMA to name a few. Testing both blood and urine is essential to providing a more complete picture of the crime as urine testing will help identify the type and quantity of substances while blood testing will help identify the behaviorial, cognitive, and physical capacities of the victim when the crime occurred. This data will assist investigators and prosecutors in establishing the victims capacity to consent which is crucial in achieving a successful outcome for those respective cases.

### **Supporting Data:**

The END Program currently has 83 active cases. Around 50 have already been closed by entering into a plea bargain or diversion program with customized treatment planning. Some cases, after evaluation by the probation department showing a deeper addiction, have been transferred to Fort Bend County's Drug Court (CARD) and can be ready for disposition (and treatment) sooner with the same expedited lab reports. CARD's caseload from 10/01/2021 until 9/30/2022 was 83 clients. However, the total number of participants fluctuates with 50-60 being optimal per our probation department. Presently, the use of toxicology testing for sexual assault victims is not common practice. However data from local law enforcement reveals a potential opportunity to improve the outcomes of these often complex cases. A 2022 study published in the Journal of Forensic Sciences which evaluated suspected drug-facilitated sexual assault cases in the city of Houston from 2014 to 2020 retroactively tested a total of 1240 samples (1230 cases) for a six-year period that consisted of blood, urine, or both specimens and found that 22% of samples tested positive for the presence of drugs including ethanol, THC, and several substances labeled as "Unknown". Unfortunately, almost 90% of cases where the presence of drugs was confirmed resulted in no charges being made due to lack of evidence. Dempsey SK, Rodgers CL, Stout P, Lee D. ## **Project Approach & Activities:**

The goal of the program is to identify issues in each case that can be addressed with either substance abuse treatment or through other community services that can help prevent the individual from engaging in further criminal behavior. The END docket uses three screening tools for assessment which include the Substance Abuse Subtle Screening Inventory (SASSI), Texas Christian University Drug Screen 5, and the Texas Risk Assessment System (TRAS). Individuals are also screened for addition unmet needs and provided referrals for mental health services, educational and vocational services, and housing needs. The program will utilize the Texas Work Force Commission, the Literacy Council of Fort Bend, Texas State Technical College, Wharton County Junior College, and the Fort Bend County Behavioral Health Department. The program will use Fort Bend Regional Council, Turning Point and Bay Area Recovery for substance abuse treatment and Texana, the Local Mental Health Authority, for mental health treatment. The goal of the Systematic Toxicological Analysis Project is to decrease the rates of dismissal and increase the rates of convictions in cases where a drug facilitated sexual assault is suspected. The need for systematic toxicology analysis is critical in some sexual assault cases. In sexual assault cases where a victim reports the assault within 5 days, a forensic sexual assault exam can be completed. During forensic sexual assault exams, if the victim indicates that they either voluntarily, or believes they involuntarily consumed drugs or narcotics of any kind, then a sample of the victim's urine and/or blood is collected during the forensic exam. In these cases, the toxicology analysis of the victim's blood/urine can be important for different reasons: 1. It can verify the victim's account of what substances the victim consumed prior to the sexual assault or 2. It can provide evidence of a drug facilitated sexual assault and help the victim, investigators, and prosecutors understand whether and what substances a perpetrator administered to the victim. The program will utilize counseling services available through the Fort Bend County Women's Center, Family Houston, Catholic Charities of the Archdiocese Galveston-Houston, and HGI Counseling Center as well as civil legal assistance provided through Lone Star Legal Aid.

## Capacity & Capabilities:

The DA's Office represents the State of Texas in state criminal prosecutions for crimes that occur in Fort Bend County. We have 156 employees consisting of 78 attorneys, 21 investigators, and 58 support staff. Fort Bend County has a well developed criminal justice system that already includes specialty courts in addition to END and CARD. The Court will be staffed with deputy district clerks, court-appointed and retained counsel, staff from Fort Bend County Community Supervision and Corrections Department (CSCD), assistant district attorneys, Judge Chad Bridges of the 458th District Court, Judge Tameika Carter of the 400th District Court and all the other court staff necessary to run the docket. We are committed to eventually having recovery coaches and other community services available for those who wish to accept responsibility and begin a customized treatment program. The Adult Sex Crimes Unit is part of the Special Crimes Division of the Fort Bend County District Attorney's Office. The Adult Sex Crimes Unit, in addition to having its own specialized prosecutor supported by a grant through the Violence Against Women Act, leverages investigator capacities and other resources available through the Domestic Violence Unit within the Special Crimes Division.

## **Performance Management:**

The overall goals are to quickly evaluate and appropriately place drug offenders that are willing to accept responsibility in an individualized treatment program on an expedited basis. The END docket matches needs to resources for those who remain on the docket during supervision and appropriately place other offenders in Fort Bend County's Drug Court (CARD), Mental Health Court, Veteran's Court, inpatient treatment or whatever diagnostic testing the Fort Bend County CSCD indicates is appropriate. Those who are placed directly to CARD from a regular felony docket will also utilize grant funds for expedited qualitative testing. The goal of the Systematic Toxicological Analysis Project is to facilitate a faster timeline for testing in hopes of achieving a more successful outcome for cases involving drug facilitated sexual assaults. The time limitations of DPS's toxicology testing can negatively affect sexual assault investigations and prosecutions. Victims of sexual assault are less likely to be cooperative the longer an investigation or prosecution takes, especially when the cause of delay is something within the State's control, such as toxicology testing. Further, when sexual assault investigations are delayed because of toxicology testing, then perpetrators are not charged with a crime for a longer period of time, and they can possibly reoffend during the time it takes to complete an investigation that is waiting on toxicology results. This project will track the number and tyoes of substances tested for, the results of those tests, average length of time to receive results, and the outcomes of cases where systemic toxicological analysis was used.

#### Target Group:

The Expedited Narcotics Docket and CARD target defendants with low level felony narcotics cases for quick disposition with tailored treatment options. Appropriate cases on the END docket will be moved to specialized dockets (including CARD) to allow more resources

for District Court Judges to try other higher degree violent offenses. The program excludes delivery and manufacture cases. The target group for using systematic toxicology analysis are cases which are suspected either by law enforcement, investigators, or prosecutors as drug facilitated crimes. The target group for the Systematic Toxicological Analysis Project are victims of sexual assault who report memory loss or having "snapshots" or "cameo memories", confusion, impaired motor skills, reduced inhibition, dizziness, drowsiness, impaired judgment, or intoxication disproportionate to the amount of alcohol consumed. Victims who also describe scenarios commonly linked to drug facilitated sexual assaults will also be included for toxicology analysis. These include situations where the victim remembers taking a drink but cannot recall what happened for a period of time after consuming the beverage; the victim feels a lot more intoxicated than her/his usual response to the amount of alcohol consumed or feels intoxicated after drinking a non-alcoholic beverage; the victim woke up feeling "hung over" or "fuzzy," experiencing memory lapses and unable to account for a period of time; the victim feels as though someone had sex with her/him, but cannot recall any or all of the incident; the victim wakes up in a strange or different location without knowing how she/he got there; or the victim's clothes are absent, inside out, disheveled or not hers/his.

#### **Evidence-Based Practices:**

The process the Expedited Narcotics Docket mirrors the successful re-integration court model employed in Harris County. The use of customized treatment options applied after pre-disposition assessment led to lower recidivism for individuals with small drug offenses. As the END docket continues to operate, we are collecting information for evaluation and improvements. CARD is a standing Drug Court that has proven record of success. According to recent studies and case analysis, the use of Gamma-Hydroxybutyric acid (GHB) and its metabolic precursors, Gamma butyrolactone (GBL) and 1,4-butanediol (1,4-BD), may be among the most favored drugs used to commit drug-facilitated sexual assault (DFSA). Marinetti L, Montgomery MA. The Use of GHB to Facilitate Sexual Assault. Forensic Sci Rev. 2010 Jan;22(1):41-59. PMID: 26242455. The use of GHB in these types of cases creates a challenge for investigators and prosecutors due to the both the sedative and memory imparing effects of GHB combined with the lack of readily available testing options which screen for this often difficult to detect compound. Accredited private labs such as NMS provide expedited testing to screen blood and urine samples for the presence of GHB and other pharmaseuitcal substances in suspected cases drug facilitated sexual assaults. We believe the ability to leverage this resource can provide verification that a drug facilitated sexual assault took place and assist investigators and prosecutors with proving the victim was incapacitated at the time of the assault and lacked the capacity to give consent thus increasing the likelihood of convictions and decreasing the rates of dismissal in these cases.
